


Ellen was the most durable Harn of all, reaching age 101 at the time of her death in 1930. Her grandparents were **Caleb HARN** and his first wife **Sally DAVIS**. She is not a direct ancestor of the KY HARNs or DAVISes but she is included in this book due to her

significant contribution to HARN and DAVIS family research. She was named after her great-grandmother, **Dorcas DAVIS**. She never married but lived for many years with her sister's family (Sarah Anne HARN Williams). When Sarah Anne and her husband settled



in Kennesaw, Nebraska, with a land grant, Ellen joined them. She was a school teacher who campaigned for women's suffrage (voting rights) and temperance (prohibition of alcohol). In her day, these two issues were linked in a liberal political agenda. She made her first airplane flight in 1918 when she was 89 years old. When the plane flew over the house-tops of Kennesaw, she re-

leased a banner saying, "Votes for Women" clearly visible to the crowd below. She collected, researched, wrote and preserved scores of important HARN family details, culminating in her well-known manuscript. Some of her original papers are with her great-grandniece, Aileen Farleigh LINCH (as of 2007). The Harn Homestead Museum in Oklahoma was orig-



inally built by Ellen's nephew, William Freemont HARN. Her brother, George Upton HARN (the elder), was a well known minister and Union soldier. One of the first women to hold positions of influence in her chosen field of education, Ellen was a largely self-taught intellectual and a strong supporter of women's rights and the abolition of slavery. There is a possibility some of her original papers are at a university in Nebraska.

INTRODUCTION

This booklet compiles information on two of the children of **John HEARN and Dorcas DA-VIS** of Frederick Co. MD.

John and Dorcas DAVIS HEARN were both born about 1735-45 in MD. Their ancestry is not proven. Eleven children are attributed to them. Only one, son Caleb HEARN, remained in MD. The rest migrated out of the state. Most went to PA, two went to Ohio and two went to KY. The KY migrants were Elijah HEARN and HESTER HEARN. They were the first to leave MD and did so shortly after KY became a state in 1792.

Elijah and Hester HEARN, their spouses and families, are the subject of this booklet.

This booklet also tries to unravel, using circumstantial and hard evidence, the relationships between the various DAVISes that are intertwined with the HEARN family in both MD and KY. (HEARN is also spelled HARN, HERON, HERN, HERRING, HURN, etc.)

We know of 4-5 DAVIS / HARN marriages:

About 1760

John HEARN m. Dorcas DAVIS in MD. No record exists. They are the parents of Elijah HARN and Hester HARN (among others). They stayed in MD.

About 1760

Nancy (unkn) m. Garrard DAVIS in MD. No record exists. Nancy's maiden name may or may not have been HARN (see John E. HARPER's notes, following pages). This couple migrated to KY about 1796 with other family members and neighbors. They are the parents of John DAVIS who married Hester HARN and Cassandra DAVIS who married Elijah HARN.

23 Mar 1788

Caleb HARN (son of John and Dorcas Davis HARN) m. Sarah DAVIS by license. Witnesses were Elijah and Matthias HARN (Caleb's brothers) & John DAVIS (John was probably the same as above and possibly a brother to Sarah DAVIS). Caleb's family stayed in MD. John P. HARN, the complier of this book, descends from Caleb HARN and his 2nd wife, Charity DUVAL while LouAnn Harn CAMERON, who helped research this book, descends from Caleb and his first wife, Sarah DAVIS. Sarah DAVIS died about 1803 and according to Ellen D. HARN who wrote about 1880: Sally (Sarah) Davis, is buried in the Davis family burying grounds on the farm a mile or less east of the Mount Airy B.& O.R.R. a beautiful farm once owned by the Davis family. There is no headstone to mark her grave. The farm is now owned by Thomas Clary.

6 September 1787

Elijah HEARN (son of John and Dorcas Davis HARN) **m. Cassandra DAVIS**, daughter of Gerrard & Nancy DAVIS, by license. Witnesses: John HEARN and son Jacob HEARN ("Jacob" is probably a mis-recording of "Caleb" HEARN) & <u>Francis DAVIS</u>. Francis is likely the brother of Cassandra (rather than her grandfather of the same name). This family went to KY about 1796 with John and Hester HARN DAVIS and others.

About 1792

Hester HARN (daughter of John and Dorcas DAVIS HARN) m. **John DAVIS**, son of Gerrard and Nancy DAVIS. No record exists. This family went to KY abt 1796 with Elijah & Cassandra Davis HARN and others.

PROFILE OF JOHN & DORCAS DAVIS HEARN of Frederick Co. MD

Parents: Unknown.

Birth: Birthdates and birth locations are unknown.

Marriage: Unknown date and place but about 1762. (Dorcas' actual given name could be Tabitha.)

Children: Caleb B.1763. M. Sarah DAVIS 1788. M. Charity DUVALL 1809. D. 1840, Frederick, MD.

Elijah B. about 1764. M. Cassandra DAVIS 1787. To KY about 1793 (with Hester). D. after 1814 in KY.

Denton B. 1769-79. M. Rachel PICKETT 1801. To Ohio after 1820. D. 1836, Western Ohio.

Mathias B. before 1770. M. Amelia SHIPLEY 1798. To Ohio after 1830? Maybe died after 1860 Darke, Ohio.

Greenbury B. about 1771. M. Sarah GRIMES 1787. To PA after 1813. D. after 1830, Fayette, PA.

Hester B. about 1773. M. John DAVIS about 1792. To KY about 1793 (with Elijah). D. 1831, Shelby, Indiana.

Ary (female) B. about 1782. To PA about 1815. D. 1845, Fayette, PA.

Ellen B. about 1785. M. Jonathan CRAWFORD. To PA about 1815. D. about 1846, Fayette, PA. **Horatio** B. about 1787(?), Migrated to Ohio? D. in Ohio? No record exists mentioning Horatio.

Harriet B. 1787. M. Joshua GRIMES 1808. To PA abt 1815. To Ohio about 1825. D. after 1850 Jefferson, OH.

Johnzee B. about 1791. M. Elizabeth OVERTURF. To PA about 1815. D. after 1850 Fayette, PA.

Death Both died 1811-19 in Frederick County and were buried near Mt. Airy MD in unmarked graves.

Family John and Dorcas had 11 children over a span of about 27 years. They were still having children when they were grandparents. Dorcas would probably have been a maximum of 42 years old at the birth of her last child about 1791, meaning her birth year was probably about 1745. John was probably at least 5 years older than she (although 15 years older would not have been unusual). So he was probably born before 1740. We know John was still alive in 1810 (but not in 1820) giving him a life span of between 70 and 75 years. We know Dorcas was also alive in 1810 (but probably not in 1820) giving her a life span of between 65 and 70 years. If she lived until 1820, it is not known whom she lived with since she does not appear with Denton or Caleb in that year. We suspect that John outlived Dorcas by a few years.

Finances It seems the family of John and Dorcas HARN was of modest means. Neither John nor any of his sons left a will (that we can find), suggesting (but not proving) there may have been little to pass down. Records show John first owned land in 1805, when he was probably about 70 years old. That record is a "rent-to-own" contract dated 1801 and speaks of a future transfer of 174 acres of land to John's possession in 1805. Ellen Dorcas HARN's manuscript says this land was called "Fair Hill." She also implies John was living there as early as 1763, when son Caleb was born, Prior to 1801 John probably rented this same land from Caleb Dorsey Jr. (1710-72). This land, part of a tract called Caleb's Delight, was inherited by Samuel DORSEY who sold it to Robert ISRAEL who died in 1795 before the sale could be recorded. A 1793 tax record shows John with no taxable property (since he rented) and a slave which he did not own. Therefore, he was not taxed in that year. According to the same tax record, a slave lived on his rented farm but was owned by landlord Robert ISRAEL. In 1810 John sold his land to son Denton who kept it only one year before selling it to a neighbor, Upton HAMMOND. The land appears to have been hilly and wooded and John may have been primarily a woodcutter. There is no record of any Frederick County HEARN or HARN in this book's direct lineage owning other land, slaves or businesses (although side-braches of the family did). Most were farmers or carpenters. Of John and Dorcas' children, it appears only Caleb remained in Maryland, living out most of his life on (or very near) the original Fair Hill farm where he was born, but never coming into possession of it. Caleb was a builder, not a farmer and this might explain why Fair Hill was passed to his brother Denton. There is no record of Caleb leaving anything to his heirs and this is also true of Caleb's son William A. HARN, who, together with his wife and 8 children, left Maryland for Dayton, Ohio about 1857, suggesting they too were not land owners in MD. Caleb lived the last years of his life in his daughter's home. His brothers and sisters all migrated out of the area, to Pennsylvania, Kentucky and Ohio (except Mathias who moved first near Baltimore and may moved to Ohio later in life). A lack of inheritance might have been the reason why none of the children stayed where they were born. This does not necessarily mean the family was poor. Denton left for Ohio in the 1820's where he operated a stage coach line for a while between Maryland and Dayton, Ohio. But he never settled in Dayton. Greenbury bought and sold land near Fair Hill 1804-13 and also in nearby Baltimore County. Mathias is also shown owning 150 acres of land in Baltimore County on an 1813 tax list (and again in 1823). No purchase deed has been found but there is a sale record. He appears to have inherited this land from his father-in-law, Peter SHIPLEY.

Religion Two of John and Dorcas' children were married in a Lutheran Church: Caleb to Sarah DAVIS and Elijah to Cassandra DAVIS. The original marriage records might be in German. These DAVISes are probably relations of their mother, Dorcas DAVIS. It is unlikely Dorcas or John were German or Lutheran. They may have used the Lutheran church since Anglican churches were too "English" at a time when it was important to demonstrate one's distance from symbols of the English "oppressors" and there were many German's nearby. Of the given names of their children, only Mathias was common in Germany. All other names were English. Family history repeats the story of the HARN line being originally from Wales. Daniel HEARN, the likely but unproven father or grandfather of John HEARN, was British, likely Irish Catholic. Of John & Dorcas's children, only Mathias appears to have had a spouse of German ancestry, despite there being many Germans nearby. Caleb's son & grandson, William A. and Grafton, were Methodists in MD & Baptists after moving to Ohio. Elijah HARN's second marriage was performed by a Methodist preacher in KY.


FROM MARYLAND TO KENTUCKY

It isn't known for sure how Elijah and Hester HARN and their families reached Mason County KY from Maryland about 1796, but for most Marylanders, the early route to Kentucky started overland to Pittsburgh, then down the Ohio river to Maysville (first called Limestone), which was Mason County's original landing place. **Elijah and Hester HARN** and their families probably followed this route, disembarked at Maysville and moved inland by wagon. Indian attacks were common, especially in the interior of the state, until the final defeat and pacification of the Midwestern tribes in 1795 with the treaty of Greensville.

In some areas of KY, the land was poor for farming. The following passage is reprinted from a 1897 article by J. E. Coad, describing Maryland migrants to Nelson KY:

"When I was a boy there was a tradition rife here to the effect that when the old pioneers used to meet Saturday evenings, as soon as they had shaken hands, one would turn his back to the other and beg him for half a dozen kicks under his coat-tail, and when they were duly administered, the other would turn around and ask his friend for his kicking. Not infrequently, half a dozen pairs have been noticed exchanging civilities of this nature, in the course of an afternoon. Why was this done, you ask? Why, in order to get temporal punishment inflicted, to expiate the grievous sin they had committed in abandoning the peaceful shores of Maryland for the wild forests and savage Indians of Kentucky. But the plunge had been made, the labor and exposure of going forbade the idea of return, and it was a clear case of "root hog or die".

Many pioneer families or their children, including our HARN and DAVIS families, eventually moved on to other states as they were created out of new territories. Some of our DAVISs went to Shelby Co. IN and some of our HARNs went to Adams Co. OH, among other locations in IN, IL, etc. Others remained in KY.



Early Kentucky History

Before the arrival of the first white settlers. Shawnee tribes from the north and Cherokee / Chickasaw tribes from the south competed for control of the "Great Meadow," a unique area of prairie grass and good buffalo hunting in central KY. But no one Indian nation held possession of the land and there were no large Indian settlements in KY in the mid-1700s. Iroquois from the north also hunted there. The first white exploration of the area was made in 1750 by a scouting party led by Dr. Thomas Walker from Virginia. As more settlers entered the area, warfare broke out with the Indians. The Iroquois sold their claim to much of what is now Kentucky to white settlers in 1768, as did the Shawnee in 1774, and the Cherokee in 1775. They didn't have much choice. However, this last treaty was not recognized by the Cherokee Chief Dragging Canoe. During the American Revolution, white settlers began pouring into the region and Dragging Canoe responded by leading his faction against them in the Chickamauga Wars (1776-1794). This was during the height of the War for Independence. The Shawnees north of the Ohio River were also unhappy about Colonial settlement of KY and allied themselves with the British during the American Revolution. Kentucky was a battleground during the Revolutionary War. The Battle of Blue Licks, one of the last major battles of the Revolution, was fought in KY. Fighting between Indians and Whites continued after the Revolutionary War ended. According to a U.S. government report, almost 1,500 KY settlers were killed in Indian raids between 1780 and 1790. In an attempt to end these raids, Clark led an expedition of 1,200 drafted men against Shawnee towns on the Wabash River in 1786 in one of the first actions of the Northwest Indian War. After 1775, Kentucky grew rapidly as the first American settlements west of the Appalachian Mountains were founded, with settlers primarily from Virginia, Maryland and Pennsylvania. The most famous of these early explorers and settlers was Daniel Boone, one of the founders of the state. In the late 1700s, tobacco, corn, and hemp became major crops and the hunting stage of frontier life slowly faded away. Kentucky County was created on December 6, 1776 as a western county in the state of Virginia, which claimed the entire Kentucky territory. In November, 1780, Virginia divided Kentucky County into three counties: Fayette, Jefferson, & Lincoln.

Separation from Virginia

Several factors caused Kentucky to separate from Virginia. First, traveling from KY to the Virginia state capital was long and dangerous. Second, offensive use of local militia against Indian raids required authorization from the governor of Virginia and the local population did not appreciate the delay. Last, Virginia refused to recognize the importance of trade along the Mississippi River to Kentucky's economy and trade with the Spanish colony of New Orleans, which controlled the mouth of the Mississippi, was forbidden, despite having a high potential. The magnitude of these problems increased with the population of Kentucky County and led to a constitutional convention in Danville in 1784. General James Wilkinson proposed secession from both Virginia and the United States to become a ward of Spain, but the idea was defeated. Finally, on June 1, 1792 the United States Congress accepted the Kentucky Constitution and admitted it as the first state in the new west.

Religious Movements

The KY frontier, saw a rapid growth in church members. Revivals and missionaries converted many previously "unchurched" settlers and drew them into the Baptist, Methodist and Presbyterian faiths. In 1801 in Bourbon County, a "Western Revival", attracted thousands of religious seekers under the leadership of Presbyterian preacher Barton W. Stone. The preaching, singing and converting went on for a week until both humans and horses ran out of food. Baptists flourished in Kentucky. Many had immigrated en masse from Virginia. The Upper Spottsylvania Baptist congregation left Virginia and came to KY in September 1781 as a single group of 600 people. Some were slaveholders. Among the slaves was Peter Durrett, a Baptist preacher. In about 1790 he founded the First African Baptist Church in Lexington, the oldest black Baptist congregation in KY and the third oldest in the United States. He was so popular that his funeral was said to be second in size only to that of the famous Kentucky statesman, Henry Clay. Many anti-slavery Virginians moved to KY as well, making the new state a battleground over slavery. Emancipationist Baptists created new churches in Kentucky around antislavery principles. The proslavery position, held by mainstream Baptists, was based on the importance of slave labor on plantations and became the dominant Baptist belief in Kentucky. During the Civil War, Kentucky was a border state, which meant it did not secede from the Union (barely), but it was not at war with the Confederacy either.

In late 1811 and early 1812, Western Kentucky was heavily damaged by a series of earthquakes referred to as the New Madrid earthquake, the largest recorded earthquake in the contiguous United States. These earthquakes caused the Mississippi River to change course, creating the Kentucky Bend in that river.


Mason County was established by the Virginia legislature in 1788 from Bourbon County. Nineteen Kentucky counties were later formed from the original Mason County, including Fleming County in 1798 and Lewis County in 1807. Mason County's original landing place on the Ohio River, was first called Limestone, then Maysville. It isn't known exactly how Elijah and Hester HARN and their families reached Mason County from Maryland in 1793, but they may have floated down the Ohio River by boat or barge and disembarked at Maysville.

William DAVIS lived near Rezin W. DA-VIS, Jarred HERN and John and Hester HARN DAVIS in Lewis Co KY in 1820.

Francis DAVIS lived directly next to Charles DAVIS and about 20 households away from Mathias (Tison) DAVIS in Lewis Co. 1810. He lived near Nathan, Rezin & Cordelia HARN in Fayette Co. IN 1820.

Notes: Mathias DAVIS has 2 slaves in 1810 in Lewis Co KY and Garrard DAVIS willed 1 slave to his wife Nancy in 1804. This slave made it to Shelby Co. IN with Rezin DAVIS, son of Garrard, and is buried in the Davis Cemetery in Shelby IN.

Sarah DAVIS (m. to Caleb HARN, above) may be another child of Garrard DAVIS. She stayed behind in MD & died abt. 1802.

Garrard and Mathias are 99.9% for certain siblings. Dorcas may be a sibling or 1st cousin.

WILL OF GARRARD DAVIS OF MASON CO. KY, 1804

In the name of God Amen I Garrard DAVIS of Mason County and the State of Kentucky being sick and weak of body but of perfect mind and sound memory Do make this my last will and testament hereby revoking and? all and every other will heretofore made by me and what worldly goods it hath please the Almighty to bestow on me I do hereby dispose of them in the manner following (VIZ) It is my desire that all my just debts and funeral expenses be paid as soon as is convenient and in such a manner as my executor herein after mentioned shall think proper. FIRST. I give unto my beloved wife Nancy all my estate both real and personal during her life or widowhood with this reserve that at the death of my said wife the Negro woman Jenny shall have her freedom. SECONDLY, I give to my son Charles a feather bed and furniture one rifle gun and one black colt immediately after my demise to him and his heirs forever also one cow and calf to my said son. THIRDLY, I give to my son Nathan DAVIS one feather bed and furniture one sorrel colt and one cow and calf as soon as he shall arrive at the age of twenty one years to him and his heirs forever. FOURTHLY, I give to my son Reason one featherbed one colt and one cow and calf as soon as he shall arrive at the age of twenty one to him and his heirs forever. FIFTHLY, It is my desire that after the death of my wife that all the estate that remains after the ____ is paid in her hands hall be equally divided amongst my children namely Cassa HAIN, John DAVIS, Garrard DAVIS, Benjamin DAVIS, Francis DAVIS, William DAVIS, Charles DAVIS, Nathan DAVIS and Reason DAVIS also my son in law Joseph **SPINNER**. SIXTHLY and lastly, I hereby appoint my beloved wife Nancy executrix and my son Charles DAVIS and son in law Joseph SPINNER executors of this my last will as witnesses my hand and seal this 14th day of December, 1804. Signed, sealed and acknowledged in presence of Winslow PARKER Jr. and Benjamin LEE.

The will was proved in court by the oaths of Winslow Parker Jr. & Benjamin Lee and recorded in April 1808. In September 1820, "Joseph SPURRIER one of the executors named in the last will & testament of Garrard DAVIS deceased came into court & qualified thereto and on his motion certificate is granted him for obtaining a prorate thereof in due form upon his giving security whereupon he together with Winslow PARKER Jr. & Thomas WELLS Jr. his securities entered into & acknowledged bond in the penalty of 300 dollars, conditioned as the law directs." Attested by Marshall KEY, clerk. NOTE: Thomas WELLS Sr. lives near DAVISes and CLARYs in Frederick Co. MD 1790. & Winslow PARKER lives near John DAVIS & Hester HARN in Lewis Co. KY 1810.

Charles was born before 1783. Nathan & Reason were born after 1783. Two daughters are married to men from Frederick Co. MD: Cassandra to Elijah HARN & Eleanor to Joseph SPURRIER. It isn't clear why Garrard provided for the husband of daughter Eleanor DAVIS, namely Joseph SPURRIER, but provided directly for daughter Cassandra HARN & not for Cassandra's husband, Elijah HARN. NOTE: This is not from the original, handwritten will. This is a handwritten copy of the original, which may explain the miss-transcriptions of HARN & SPURRIER.

A Garrard DAVIS appears with Francis DAVIS <u>Sr.</u> in a Frederick Co. Md 1778 deed & in another deed with children of Francis DAVIS Sr. very strongly suggesting Garrard is a son of Francis DAVIS Sr.

Wife Nancy appears in the notes of Rezin's descendant John E. HARPER as "NANCY HARM". This may be incorrect. See next page.

Jenny is mentioned (not named) on 2 other documents about the IN Davises

Charles is near Mathias & Francis DAVIS in Lewis Co. KY, 1810.

Charles & Nathan are near Rezin DAVIS & Cordelia HARN RAVENCRAFT in Fayette Co. IN in 1820.

Rezin buys land in Fayette Co. IN in 1812 with brother Charles.

"Cassa HAIN" is likely Cassandra Davis HARN, 1st wife of Elijah HARN and sister of John DAVIS who m. Hester HARN.

John DAVIS' wife is Hester HARN, sister of Elijah HARN.

"Joseph SPINNER" is Joseph SPURRIER who married Eleanor "Nellie" DAVIS in Frederick Co. MD in 1788.

Joseph SPURRIER lives next to a brother-in-law of Elijah HARN's daughters (Tolle) in Lewis Co. KY in 1820.

In 1830 Rezin DAVIS lives next to John & Hester HARN DAVIS, Shelby, IN.

Francis DAVIS lives with Charles and near Mathias DAVIS in Lewis Co. KY 1810 & near Rezin, Charles, Nathan & Cordelia HARN Ravencraft in Fayette Co. IN in 1820.

Benjamin Davis served in the War of 1812. He moved to Schuyler Co. IL bef. 1832.

Supporting the Previous Pedigree

Family history notes written by John E. HARPER, great-grandson of Rezin DAVIS (of Gerrard DAVIS), the early Shelby Co. Indiana settler:

"As well as I can find out **John DAVIS** married **Nancy HARM (sic)** in Maryland. They moved to Fleming County, KY then they moved to Indiana - maybe - 4 sons and one daughter came here - two sons **William** and **Benjamin** remained in Ky....& one daughter...married Clary. The sons moving here (Indiana) were **Rezin**, 1788-1843/4,...**John, d. 1837** ...**Nathan**, who evidently settled in Van Buren Twp. (Shelby Co., Ind.) for a time, ...**Charles** who lived near Connersville. ...he (**Rezin Davis**) married...his cousin...Nancy Clary...1792-1854...in Kentucky..."

"...The story comes to me ... my notes say... that **John DAVIS**, brother of **Rezin DAVIS**, married **Hester HARM** in 1792-or-4 - probably in Maryland- came ... emmigrated ... to KY in 1795 with his father - name unknown - and brother-in-law Elijah HARM - then followed his brother Rezin here (Indiana) in 1828...Now, I don't know how much is truth and how much is fiction. If **Rezin DAVIS** had five brothers and two sisters, (John P. HARN's note: The 2 sisters were Cassandra Davis HARN and Eleanor Davis SPURRIER) there was a pretty good family of them. Then he had nine (meaning Rezin (of Gerrard) had 9 children of his own). I know his line is correct - but the brothers & sisters are hearsay..."

The above was sent to John P. HARN by Darlene PALMER, a descendant of Rezin DAVIS, in 2011. John P. HARN believes (but cannot prove) the first paragraph contains some errors. For example, the husband of Nancy was Garrard DAVIS, father of John DAVIS. This couple did move from MD to Mason Co. (although Fleming Co, KY was later carved from Mason Co.), but they never migrated to IN... although their offspring did. It appears John HARPER has combined details of Gerrard DAVIS who m. Nancy together with that of their son John DAVIS who m. Hester HARN.

The descriptions of early DAVISes in Shelby Co. Indiana below may be variations on the original notes by John E. HARPER, above.

Rezin DAVIS, b. 1788, d. 1844, came to Indiana from Fleming Co. KY with his father Joem or John and mother Nancy HARM and his brothers Nathan (who lived in Van Buren Twnship, Shelby Co) and Charles. Rezin and Charles bought land January 12 1812 in Fayette Co. IN. Rezin and his wife Nancy CLEARY settled in Hanover Township, Shelby Co. IN filing the 3rd land claim in the area in October, 1820. Morristown was platted by Rezin DAVIS. The townspeople wanted to name the town Davisville after him but Rezin's wife, Nancy Cleary DAVIS, requested it be called Morristown after their friend and minister, Samuel Morrison. Rezin helped establish the first school and was instrumental in all affairs of the town. He was a state representative in 1828. He is buried in the Davis family cemetery in Morristown. (other DAVISes are buried in nearby Ashbury Cemetery, also in Morristown). Submitted by Paula M. HALE

YOUR TOWN — MORRISTOWN By Hortense Montgomery

One of the most interesting characters of Morristown's later history was Mrs. Florence Johnson Rock, who passed away only a month or two ago at the age of 97. **Mrs. John E. Harper**, historian for the Morristown community, published an attractive brochure of her life as presented by her to be given out at the annual Old Singers meeting last summer. Her recital of the early days of the village and its pioneers is romantic and a true history of the business, social and religious file of the community.

Mrs. Rock's father, Samuel M. Johnson, graduate of Asbury College, now DePauw University, became a teacher and successful farmer of the community. Her mother was **Zelda Spurrier**.

Rev. Sluter says that as early as 1819 Joseph Hewitt and Firmin Smith came from the neighborhood of Brookville and began clearing away the dense forests. And the first four wheeled wagon in Shelby county of which we trace can be found was owned by Mr. Hewitt.

Col. Rezin Davis, great grandfather of John E. Harper entered the land of which Morristown stands on October 1820. Those who were pioneers with him at that date were John Wilson, William Johnson, Benjamin Cole, William Griffin, Eleazer Burham, Nathan Davis, F. Lucas, S. M. Cole, K. Kitchell, Josiah Glover, Joseph Hewitt, Firmin Smith and Michael McCord.

At this early date there was a rift between the North and South over slavery. Col. Davis had freed his slaves before coming North but one old Mammy followed the family, found a good home with them and was buried on an acre of ground which Col. Davis set aside on his farm for a burial place; this was the beginning of the Davis graveyard.

Morristown was laid out by **Col. Davis** and Samuel Morrison May 3, 1828, the third town organized in the county. It was surveyed and platted by Meridith Gosney, with 48 lots, each 60x132 feet; the streets were 60 feet wide and the alleys 20 feet wide. The principle street, called Main street, was Road 52 or the Brookville Road. An addition, the **Rezin Davis** Addition was mapped July 3, 1840, with 24 lots.

Elijah HEARN m. Cassandra DAVIS by license. Witnesses: John HEARN and son Jacob HEARN (probably Elijah's father & brother Caleb) & **Francis DAVIS**. This is not Francis DAVIS Sr, father to Mathias Davis because Francis Sr. died 1778. Francis is likely the brother of Cassandra Davis HARN and the son of Garrard DAVIS. Elijah HARN married Mary TOLLE Feb 1, 1814 in Lewis Co. KY after the death of Cassandra DAVIS. Elijah died about 1819.

Hester HARN m. John DAVIS in Frederick Co. MD about 1792

Ellen Dorcas HARN paraphrases Eden H. DAVIS (below): (Hester HARN's) marriage to John DAVIS, took place 1792-94 in MD. She left Maryland with her husband, her husband's father & her brother Elijah & migrated to KY in the fall of 1793." The father of John DAVIS was Garrard DAVIS, m. to Nancy (unkn). John & Hester HARN DAVIS moved to Shelby Co. IN abt. 1828. Hester died 10/11/1831 & John died 7/7/1837, both in Shelby Co. IN.

b. 1787-94 Frederick Co. MD m. May 14, 1810 Mason Co. KY Marriage record spells her surname HUME Bondsman was Elijah HUME Witness was Reuben TOLLE She d. about 1812 during childbirth.

Children of Rachel + Stephen Sanford, Jonathan, Nancy, Cynthia Ann, Denton, Isaac Newton, Jefferson, Willis, James, Emily Permilla, Wm Fletcher, Milton P. 4 married unkn DAVISes.

Henrietta HARM + Jonathan TOLLE

b. abt. 1790 in Frederick Co. MD m. June 16, 1807 Lewis Co. KY, 2nd time for him. Bondsman was Elijah HARM. They moved to Harris Co. KY She d. 1851 Harrison Co. KY.

Children of Henrietta + Jonathan: Winslow Parker, unknown female, Elijah H., Jonathan III, John Ray, Daniel (D.H.), ? Female, William H., Denton G., Amelia Ellen, unknown male.

Cordelia HURN + Isaac RAVENCRAFT Children of Cordelia + Isaac

b. abt 1793 in Frederick Co. MD m. Sept 17, 1816 Feyette Co. KY Lived in Fayette Co. IN in 1820 Lived in Lewis Co. KY 1850 w. son James.

Children of Cordelia + Isaac James b. 1829 in KY & others?

Nancy HARN + Jeremiah TOLLE

b. abt. 1790 in Frederick Co. MD m. June 16, 1807 Lewis Co. KY She d. early 1830s.

Children of Nancy + Jeremiah Horton, 4 unknown males one unknown female.

Jarred HERN very likely. See following pages.

John D. HARAN (HERN) very likely. Wife is Susan NORMAN, son is Elijah. See following pages.

Elisha HARN possible. See following pages.

Milton HARN very likely. Lives with Jarred. Record w/ John D. See following pages.

Charles F. HARN possible. Lives with John D. See following pages.

Alfred HARN very possible, but there is a chance he is a descendant of Clement HEARNE of MD's Eastern Shore, and thus from an unrelated HEARN family. A DNA test is pending to solve the issue. See following pages.

Dorcas DAVIS + Samuel FOXWORTHY

b. 1801 in KY d.1871 in KY m. Oct, 1830 in KY. She was Samuels' 2nd wife. Their 5 children were: Emily, Anne, Clarissa, Hiram, Samuel & John. All lived in Mason Co. KY about 1870. Their granddaughter, Emily Foxworthy said in 1901 there were 3 families surnamed HARN in Mt. Carmel, Fleming Co. KY about 1875, but she didn't know them (see later in this book).

Harriet DAVIS + William MEREDITH

b. July 3, 1807 in KY. d. Sept 26, 1854 in IN.
Their 4 children were:
James, Fletcher, George, Albert.
Wm. Meredith may have been from Frederick
Co. MD. Harriet was Hester's sister's name.

John M. DAVIS + 2nd wife Elizabeth ADAIR

b. April 6, 1817 in KY m. ? in IN

d. Jan 18, 1892 in IN

John's children from first marriage may have been: Lewis, Julius, Lucius & "W.R."

Ally, Elizabeth and Lilly children from 2nd marriage.

Mary Ann DAVIS + Owen DAVIS

b. 1814 d.1871 m. ?

Owen DAVIS was the son of Rezin DAVIS the elder & Mary Ann's 1st cousin. Their one child was: Nancy Jane 1840-1878 who married Erastus Harper and their child was **John E. Harper** (see previous page).

Eden H. DAVIS + Eberilla JOHNSON

b. June, 19, 1810 in KY d. May 31, 1878 in Shelby Co, IN, m. 1835 in IN. When Eberilla died 1864, Eden married her sister. The 3 children of Eden and Eberilla may have been: Azoline (female), John & Hester Anne. Hester Anne m. John A. YOUNG.

Eden corresponded with George Upton HARN Sr. (brother of Ellen Dorcas HARN & grandnephew of Hester HARN DAVIS) regarding family ancestry. Some of that correspondence has survived & appears later in this booklet.

THE MARYLAND DAVISes

With a name as common as DAVIS and a general scarcity of mid-1700 records, there is naturally some confusion regarding the early MD Davis relationships. Some DAVIS men married twice and had children by both wives resulting in families of half-siblings living together with full-siblings. Also, families were often huge, sometimes with 10+ children. Siblings' birth dates could be separated by 20-25 years, the same amount of time that separates a generation. Older children could marry and have children themselves while younger children were still being born of their parents. So it is sometimes very hard to separate generations based on birth, marriage or death year. Nevertheless ... all of the relationships on this page are either strongly supported or clearly documented by wills and deeds.

1st GENERATION

<u>Francis DAVIS Sr.</u> 1722-1778, was a son of Thomas DAVIS and Mary PIERPOINT. He lived mostly in Baltimore but owned land in Frederick Co. MD. He had two families from two marriages, 1st to Anne HAMMOND, 2nd to Katherine HOBBS. He names several (but not all) of his children in his will, including Mathias (see below) who is clearly intertwined with our DAVISes and HARNs in **KY** and IN.

Francis Sr's children with Anne HAMMOND

Francis DAVIS Jr. does not appear in Francis Sr's will but makes a claim against Francis Sr's estate after Francis Sr's death. Wife unknown. He may appear in Baltimore Co. MD in 1790 and 1800. He is likely not the Francis DAVIS who appears with other DAVISes and HARNs in <u>KY</u> and IN and is likely not the Francis DAVIS who witnessed Cassandra DAVIS' marriage to Elijah HARN in 1787 &/or who lives next to Gilbert DAVIS in Frederick Co. MD in 1790. These records likely pertain to Garrard DAVIS Sr.'s son, Francis. <u>Garrard DAVIS Sr</u>. b. abt 1740, does not appear in Francis Sr's will but is strongly connected circumstantially to both Francis Sr. himself and Francis Sr.'s other children through land deeds (see below). Garrard is in <u>KY</u> and concretely connected with other DAVISes and HARNs. His wife is Nancy (unkn).

Ruth DAVIS married Rezin WELSH before 1778. She is named in Francis Sr's will.

Mary Ann DAVIS (Polly) married Henry WELSH in 1786. She is named in Francis Sr's will.

Rezin DAVIS married Nancy PHILLIPS in 1782. This is not the same Rezin DAVIS (of Gerrard) we find in Mason KY and Shelby IN. This Rezin is named in Francis Sr's will. He did not migrate to KY.

Mathias DAVIS born 1765 married Rachel MAYNARD in MD in 1788 and moved to KY about 1796, and is very intertwined in the records with Gerrard DAVIS Sr. there. Mathias is named in Francis Sr's will.

Lucretia DAVIS married William PHILLIPS in 1787. "Lucy" is named in Francis Sr's will.

Francis Sr's children with Katherine HOBBS (of Samuel HOBBS)

<u>Samuel DAVIS</u> born 1769, married Hannah HOBBS in 1819. Samuel is named in Francis Sr's will.

<u>Zachariah DAVIS</u> b. about 1773, married Elizabeth HYATT 1794. Zachariah is named in Francis Sr's will.

<u>Ann (Nancy) DAVIS</u> married Henry MYERS in 1796. Nancy is named in Francis Sr's will.

<u>Thomas DAVIS</u> born 1778, married Amelia SHIPLEY in 1804. Thomas is named in Francis Sr's will.

Siblings of Francis DAVIS Sr.

Richard DAVIS Sr. married Ruth WARFIELD, daughter of John & Ruth (GAITHER) WARFIELD. Richard died in Washington Co. MD in 1791.

Elizabeth DAVIS m. Joseph MARRIOTT. She died 1749.

Thomas DAVIS Jr. married Elizabeth GAITHER, daughter of Benjamin & Sarah (BURGESS) GAITHER. Thomas died 1749.

John DAVIS married Arianna WORTHINGTON daughter of William & Mary (HOMEWOOD) WORTHINGTON (or... John married Elizabeth CLARK?).

Robert DAVIS, Sr. married Ruth GAITHER, daughter of John & Elizabeth (DUVALL) GAITHER, III. Robert died 1789.

Mary DAVIS married John RIGGS, son of John & Jane (WARDEN) RIGGS. Mary died 1768.

Ruth DAVIS married Joshua WARFIELD, son of Benjamin & Elizabeth DUVALL WARFIELD. This is the same Elizabeth DUVALL who married John GAITHER, III. Ruth died 1744.

Rachel DAVIS married Silvanus (Sylvanus) MARRIOTT, son of John & Sarah (ACTON) MARRIOTT.

Rachel was born 1709. NOTE: Daniel HEARN of AA Co, MD (unproven father, grandfather or uncle of John HEARN m. Dorcas DAVIS) personally knew Sylvanus and Rachel Davis MARRIOTT.

Samuel DAVIS unmarried, died 1756.

Sarah DAVIS m. John BATEMAN. Sarah born 1713.

THE MARYLAND DAVISes, continued

2nd GENERATION

Francis DAVIS "Jr." son of Francis DAVIS Sr., was not named in Francis Sr.'s will but made a successful claim against the estate of Francis Sr., confirming he was recognized as an heir of Francis Sr. The Francis DAVIS who is associated with our DAVISes and HARNs in KY and IN and who witnessed Elijah HARN and Cassandra DAVIS's wedding in 1787 is likely NOT this Francis DAVIS Jr. but rather is a son of Garrard and Nancy DAVIS, below, and the brother of Cassandra Davis (m. Elijah HARN) and John DAVIS (m. Hester HARN). A Francis DAVIS on the 1790 census (living near Gilbert DAVIS in Frederick Co. MD) had 2 sons b. 1775-1789 and a daughter. This census is not alphabetical. Gilbert Sr. and this Francis DAVIS may be closely linked. If this Francis on the 1790 census is the son of Garrard, the two sons belonging to Francis on the 1790 census might be James and George DAVIS who live very near a Francis DAVIS, Rezin DAVIS (son of Garrard DAVIS) and Cordelia HARN RAVENCRAFT (daughter of Cassandra DAVIS & Elijah HARN, below) in Fayette Co IN in 1820. No known records for Francis Jr. actually use the suffix "Jr."

<u>Dorcas DAVIS</u> was b. about 1740. She m. <u>John HEARN</u> (b. 1735-45) about 1762. She d. after 1810. We don't know who her parents or siblings were.

<u>Garrard DAVIS Sr.</u> was b. about 1745-50 in MD. Since several deeds connect him to Francis DAVIS Sr. and children of Francis DAVIS Sr., it is very highly probable that he is also a son of Francis DAVIS Sr. He married <u>Nancy (surname unk).</u> Nancy probably died 1810-1820 as she appears alone on the 1810 Mason Co. KY census but not after that. Garrard d. before 1804 in Mason KY. A Garrard DAVIS is connected to Francis DAVIS Sr. in the deed of 1778 in MD and also in a deed connected to several children of Francis DAVIS Sr. (see following page). Garrard is the father of <u>Cassandra DAVIS</u> m. <u>Elijah HARN</u> and also of John DAVIS m. Hester HARN. A "Garret" DAVIS the right age is on the 1790 census in Frederick Co. MD.

<u>Mathias DAVIS</u> proven son of Francis DAVIS Sr. was b. 1765 in MD. He married in MD in 1788 and d. 1852 in KY. His long life is well documented in KY. He appears in the 1779 will of Francis Sr. in MD. He is clearly and consistently connected to the family of <u>Garrard DAVIS Sr.</u> in KY.

Gilbert DAVIS Sr. was b. 1756-74 in MD and d. 1850 in MD. In 1790 he is in Frederick Co MD living with or next to Francis DAVIS. He didn't leave MD. We have his will. He lives next to 2 DUVALLs in Liberty Township, Frederick Co MD in 1800. He was still in Fred Co in 1820. His children were Luke, Ephiram, James, Amelia Ingman and Elizabeth LEWIS. (He has a grandson named Gilbert DAVIS). His connection to the family of Francis DAVIS Sr. and/or Garrard DAVIS Sr. is unknown.

John P. HARN speculates that all the DAVISes in the 2nd Generation above are siblings or 1st cousins.


NOTE: The unproven father, grandfather or uncle of John HEARN who married Dorcas DAVIS is likely (in John P. HARN's opinion) **Daniel HEARN** of AA Co. MD. Garrard DAVIS married Nancy, who, if John E. HARPER's notes are correct, may have been a sister or 1st cousin to John HEARN m. Dorcas DAVIS.

Daniel HEARN was brought before the court on "Catholic Troubles" in 1745. A deposition was taken from Richard WARFIELD, who knew Daniel HEARN, to determine if Daniel was guilty of slandering the King. WARFIELD testified that Augustine GAMBOL (GAMBILL) said that **Silvanus MARRIOT** heard Daniel HEARN say ... (etc).

The point is that **Daniel HEARN**, and **Silvanus MARRIOT** were on speaking terms, according to this deposition. And Silvanus Marriot's wife was **Rachel DAVIS**, sister of **Francis DAVIS Sr.** So Daniel HEARN, probable father or grandfather of John HARN m. Dorcas DAVIS, personally knew at least one sibling of Francis Davis Sr.

We also know that **Daniel HEARN** and **John and Emmanuel MARRIOT** owned adjoining tracts of land on the headwaters of the South River in AA Co MD (halfway between Annapolis and Elkridge). They were neighbors. John and Emanuel MARRIOT were brothers of **Sylvanus MARRIOT** m. Rachel DAVIS (above).

In each of the next 2 generations, there were several DAVIS / HARN marriages (4-5 in all). **Daniel HEARN's** connection to the family of **Francis DAVIS Sr**, as above, offers the possibility that all 5 of the DAVISes were related to the family of Francis DAVIS Sr. Conversely, Daniel HEARN's connection to the DAVIS family, also supports his being the ancestor of John HEARN of Frederick Co, MD. <u>In addition, another sibling of Francis DAVIS Sr</u>, **Robert DAVIS** who married Ruth GAITHER, had 5 unnamed daughters in his will, 3 of which are unidentified. Perhaps one of these might be **Dorcas DAVIS**, who m. John HEARN about 1762.




Davis STREAKER, descendant of Francis DAVIS Sr. wrote the following narrative, published in the *Carrolltonian*, a publication of the Carroll Co. MD Genealogy Society, March, 2010.

Capt. James DAVIS left Liverpool, England in 1607 for North America as a representative of the Royal Virginia Company which initially located in Maine but subsequently (1609) in Virginia. He was a navigator by trade and became commander of the fort at Old Point Comfort on the James River under Captain John SMITH. He was titled "Gentleman" and died before 1619. His wife was Rachel. Their son, Thomas Davis, was born in 1613 and died before 1683. His wife's name is unknown. He was a merchant and planter of Chuckatuck, Warwicksqueick (Indian name for Isle of Wight Co.) VA. His son, James DAVIS, married Margaret JORDAN and emigrated from Nansemond Col. VA to Somerset Co. MD in 1662. Thomas Davis, son of James and Margaret Jordan DAVIS, was born January 28, 1668 at Manokin, Somerset Co, MD. He married abt. 1696 Mary Pierpoint. In 1702 they obtained two tracts of land in Anne Arundel Co, MD at the head of the Severn River. Francis DAVIS (Sr.), son of Thomas and Mary Pierpoint DAVIS was born June 21, 1722. He first married Anne Hammond. He exchanged land he inherited in AA Co, for 700 acres of land in Baltimore Co. belonging to his wife's family. The land was located just north of Mr. Airy (Parrs Ridge as known then). This exchange was made in 1763. Sometime after that date Anne Hammond DAVIS died. About 1768 Francis married Katherine HOBBS (of Samuel). In the spring of 1778 Francis (Sr.) died, leaving Katharine a widow with children.

Mary Pierpoint DAVIS was the daughter of Henry and Elizabeth PIERPOINT. The Pierpoints emigrated from Bennington, Hertfordshire, England before 1655 with for of their children. Mary, however, was born in AA Co. Henry, who had been baptized in the Church of England, joined the Society of Friends (Quakers) and became a prominent belieer. Mary is also mentioned in Quaker meeting minutes. Mary PIERPOINT married Thomas DAVIS, a neighboring landowner of AA Co. They had 11 children (see previous page for names). Their children married into well-known local families: Warfield, Marriott, Riggs, Gaither, Clark and Hammond. Thomas and Mary Pierpoint DAVIS each lived until the spring of 1749 and died within a few weeks of each other. Thomas was 81 years old.

Francis DAVIS (Sr.) son of Thomas and Mary Pierpoint DAVIS, married Anne Hammond c. 1752 in AA Co. and had several children before the untimely death of Anne c. 1767. About 1768 Francis married Katharine HOBBS, daughter of Samuel. Francis and Katharine subsequently had children of their own (see previous page for names of all children). Francis died in 1788 and in 1799 Katherine married Gassaway SELLMAN and they also had children.



Members of this family are alternately described as being from Frederick and Baltimore Counties, MD. They owned land and/or lived in both.

Daughters Ruth WELSH & Mary Ann DAVIS are each given 50 pounds and are not given shares of land, as the others are, below.


Katherine DAVIS is Francis' 2nd wife, nee HOBBS.

This is <u>not</u> the Rezin DAVIS who migrated to KY. This Rezin moved to PA.

Mathias DAVIS migrated to KY with the others about 16 years after this will was executed.

Both Rezin and Mathias receive looms for weaving.

The siblings who receive equal share of the two tracts of land are: Rezin (didn't go to KY) Mathias Samuel Zachariah Thomas Lucy, and Nancy



Francis DAVIS' Sr.'s son-in-law, Rezin WELSH, is allowed to remain living where he now is on Francis' land, provided he "behaves himself and becomes an overlooker" (overseer of land & slaves?)

Wife Katherine (Hobbs) and son Rezin DAVIS (not the Rezin who moved to KY), are executors.

Green SPURRIER, witness, is an ancestor of John P. HARN. His granddaughter, Ruth SPURRIER, of Joshua SPURRIER, married William A. HARN, grandson of John HEARN (m. Dorcas DAVIS). Green SPURRIER was b. 1737 & died after 1787. His wife was Avis LEEK. His son or grandson, Joseph. married Garrard Davis' dau. Eleanor.

Will is signed: "F. Davis Sen." proving existence of a Francis "Jr." in 1778.

It isn't clear if the David CLARY, witness, is the same David CLARY, father of Nancy CLARY m. Gerrard DAVIS's son Rezin in KY in 1811. There were 2 David CLARYs in Frederick Co. MD in 1790, By 1810 only one remained and the other is in Lewis Co. KY, living near other DA-VISes. But since Rezin Davis (of KY) and wife Nancy Clary were supposedly cousins, this David Clary may be related by marriage to Francis DAVIS Sr.

Connecting **Gerrard DAVIS Sr. to Francis DAVIS Sr.**

Our **Gerrard DAVIS Sr.** is not mentioned in Francis DAVIS Sr's will and there is no record of Gerrard DAVIS making a claim against the estate of Francis DAVIS Sr. However, the land records below, as well as circumstantial evidence in KY and IN, very strongly suggest Gerrard is another son of Francis DAVIS Sr.

LouAnn Harn CAMERON found deeds of the sale of "Buck Bottom" and "Valley of Strife" by Francis DAVIS Sr's 7 children, as named in his will. The deed summaries are:

Mathias DAVIS, of Baltimore Co., on 14 Sep 1795 sold his 1/7 share to Solomon Longsworth of Frederick Co. MD for <u>210 pounds</u>. The deed lists the 7 children who appear in Francis DAVIS Sr's will as joint heirs. Mathias signed. Rachel (Maynard) Davis, his wife, relinquished her dower rights willingly. Witness Wm. Beatty and F. B. Sappington. Recorded 16 Feb 1796.

Samuel DAVIS of Baltimore Co. on 19 Oct 1795 also sold his 1/7 share to Solomon Longsworth of Frederick Co. MD for 60 pounds. Samuel signed. Witness: Geo Murdoch and John Ross Key. No wife relinquished dower. (Samuel didn't marry). Recorded 16 Feb 1796.

Rezin DAVIS of Woodberry Twp., Huntingdon Co., PA and Nancy (Phillips), his wife, for <u>70 pounds</u> PA money, also sold his 1/7 share to Solomon Longsworth of Frederick Co., MD. Dated 18 Aug 1795. Signed Rezin Davis and Nancy (Phillips) Davis, her mark. (This is not the Rezin DAVIS who migrated to KY.) Witness: Samuel Readle and David Stewart. Recorded 16 Feb 1796.

William PHILLIPS and Lucretia (Lucy DAVIS, daughter of Francis DAVIS Sr.) PHILLIPS, his wife, both of Baltimore Co., on 10 Oct 1796 also sold their 1/7 share to Solomon Longsworth of Frederick Co, MD for 130 pounds current money. Signed: William Phillips and Lucrecy Phillips, her mark. Witness: Jacob Young and Geo Baer, Jr. Recorded 3 Apr 1797

Gerrard DAVIS of Baltimore Co. farmer, on 14 Sep 1795 sold his right to claim future title to any part of these two tracts of land to Solomon Longsworth of Frederick Co. for <u>5 shillings</u>. His name is spelled both Gerrard and Jerrard within the deed. Signed: **Gerrard DAVIS**. Witness: Wm. Beatty and F. B. Sappington No wife relinquished dower. Recorded 16 Feb 1796.

John P. HARN's explanation of the **Gerrad DAVIS** deed above is that Gerrard didn't actually have title to the land that Solomon bought from the other DAVIS siblings. But Solomon wanted Gerrard to relinquish his right to make a <u>future</u> claim to the title of the 2 tracts. Two distinctions in Gerrard's deed, compared with all the others, suggests this is true: 1. The other DAVIS sellers received a large sum (between 60 and 210 pounds) from Longsworth. But Garrard received a pittance (5 Shillings). It is only 5 shillings since Gerrard is not selling land. Instead he is being paid to give up any <u>claim</u> to the title of the land the other DAVISes are selling, and not the title itself, which he doesn't own. 2. There is an important variation in the language in a critical area within the deed that supports this interpretation. The others' deeds say the seller gives (grants, bargains, sells, etc) all his right (title, interest, etc) **"whatsover of in and to one seventh part of two tracts"** etc. But Garrard's deed requires him to grant, bargain, sell, etc., all his right (title, interest, etc) **"whatsover, <u>IF ANY HE HAS</u> of in and to one seventh part of two tracts"** etc. Thus it is recognized that Gerrard has no current title to the 2 tracts of land. Solomon Longsworth is buying a kind of "title insurance" from Gerrard. This implies there was a basis for Gerrard to make a future claim to the other DAVISes land, which they inherited from Francis Sr. Thus Gerrard was understood to be an heir of Francis DAVIS Sr.

Regarding the above deeds, Mr. Davis Streaker says, in an email to John P. HARN in 2011:

"I am familiar with the land records associated with the division of Francis Davis' land in Baltimore County, and the role Gerard DAVIS played in representing what could have been his under age siblings. My best estimate of Gerard's relationship, if it is hazarded, is that Gerard was a son of Ann Hammond and Francis Davis (Sr.). Further, Gerard's relationship with his father was better than that of Francis II. I think this is evident from documents that have survived. Francis I and Gerrard established an "inheritence" agreement before the will was written."

And finally, there is an earlier deed connecting **Garrard DAVIS** and **Francis DAVIS Sr**: 20 Mar 1778 – **Francis DAVIS**, Sr. of Baltimore county, planter sells to Wm. BEGOLE of Frederick Co, MD, part of "Valley of Strife" in Frederick Co. on the drafts of Linganore Creek (this is exactly the HARNs stomping grounds). Witnesses: **Gerrard DAVIS** & Upton Sheredine. No wife relinquished dower.

Connecting Francis DAVIS Jr. to Francis DAVIS Sr.

Francis DAVIS Sr. died in 1778. His will, recorded the next year, left two tracts of land to be divided equally by 7 of his children. The tracts of land were "Buck Bottom" and "Valley of Strife". The children named to receive a 1/7 share were: Rezin, Matthias, Samuel, Thomas, Zachariah, Lucy / Lucretia and Nancy/Ann. Not all of his children were named in his will, exact reasons unknown. Not named in his will were Francis DAVIS Jr. and Garrard DAVIS. Francis DAVIS Sr. signed his will, "F. Davis Sen." (senior). And the administrative account settling Francis Sr.'s estate includes a cash settlement to Francis DAVIS (Jr.), a payment that was approved by the executors of Francis Sr.'s will. So there is no doubt that Francis Sr. had a son Francis Jr. Mr. Davis Streaker, a current DAVIS researcher and a descendant of Francis DAVIS Sr., says in an email to John P. HARN in 2011:

"Francis II is mentioned in the administrative account for the estate of Francis (1722-1778) along with a daughter to receive a cash bequest in identical language. The daughter is (also) mentioned in the will (itself) while Francis II is not. This suggests son Francis II is making a claim against the estate after his father had provided for him previously, but didn't note same in will. We know of wills that mention heirs who have been provided for previously and therefore will not receive bequests in the will. It appears that Francis I did not choose this provision, satisfied that the "unmentioned" were adequately sourced. This can be interpreted, as to Francis II, that his father felt he had been adequately provided for whereas he (Francis II) did not. The executors of the will decided in his (Francis II) favor."

NOTE: It is doubtful that the **Francis DAVIS** who appears in KY and IN with the other DAVISes and HARNs is the same Francis DAVIS Jr. as above, or the same as in Elijah HARN's marriage record. The Francis DAVIS who appears in KY and IN and in Elijah's marriage record is instead likely the son of Garrard DAVIS, as named in Garrard's will. Garrard DAVIS' son Francis was likely born before 1766 (to be 21 at the time of Elijah and Cassandra DAVIS' marriage in 1787). Francis Jr. son of Francis Sr. birth year is unknown. It appears that Garrard DAVIS named a son after his father.

CENSUS CORRELATIONS FOR FRANCIS DAVIS IN KENTUCKY & INDIANA

1810 LEWIS CO. KY: Francis DAVIS lives directly next to, or probably with, Charles DAVIS, son of Garrard DAVIS. A few households away are relatives of Charles DAVIS' wife, Carissa VIERS and about 20 households away is Mathias (Tison) DAVIS. This is likely Francis son of Garrard DAVIS.

1820 FEYETTE CO. IN: Francis lives directly next to the siblings Rezin, Charles and Nathan DAVIS and also near to Issac and Cordelia HARN RAVENCRAFT. Cordelia HARN RAVENCRAFT is the daughter of Cassandra DAVIS HARN. Cassandra is a sister to Rezin, Charles and Nathan. This strongly suggests this Francis is the child of Gerrard and Nancy (unk.) DAVIS, rather than Francis DAVIS Jr., above.

1790 FREDERICK CO. MD: Only one Francis DAVIS is enumerated and he lives next to or with a Gilbert DAVIS. Gilbert is fairly easy to track through MD records (did not migrate to KY) but no obvious or circumstantial evidence yet links Gilbert to the family of Francis DAVIS Sr. or Garrard DAVIS. This Francis DAVIS could be Francis Jr, son of Francis Sr, since the number of sons enumerated with Garrard DAVIS in 1790 suggests <u>his</u> son Francis lives with him.

1800 ALL COUNTIES OF MD: Only one Francis DAVIS is enumerated, in Caroline Co, MD. There is also likely a Francis DAVIS in Baltimore the right age in 1800. He appears on tax records, but cannot be found on the census.

Gerrard & Nancy DAVIS 1790 Frederick CO. MD Census

The 1790 census shows the family of Gerrard and Nancy DAVIS, about 5 years before their departure to KY. Garrard DAVIS is the father of Cassandra DAVIS & John DAVIS, both of whom married children of John and Dorcas DAVIS HEARN (see next page). Families are listed in alphabetical order so we cannot see who lived next to whom. Garrard DAVIS is on pg. 157 and John HEARN (next page) is on pg. 163.

John HEARN & Son Elijah HEARN (Herring) 1790 Frederick CO. MD Census

The 1790 census shows the families of John HEARN and son Elijah HEARN about 5 years before Elijah's departure to KY. Families are partially listed in alphabetical order so we can perhaps see who lived next to whom. The 1800 census ISin alphabetical order and it also shows Eli MURRAY below, living next to John and Dorcas DAVIS HARN. Thus we can be sure that John and Elijah HEARN, below, lived either next to each other or in the same household. Eli MURRAY may have been a boarder or hired hand.

Everyone on this page, plus Francis & Gilbert DAVIS & Caleb HEARN live in the Burnt House Woods or Unity Hundred in the Taylorsville area on the 1793 tax list.

John P. HARN speculates that Elijah's brother Caleb HEARN is enumerated with Elijah. However, since Caleb is understood to have been older that Elijah, it isn't clear why Caleb would have been enumerated under Elijah's name & not the other way around.

These males under 16 could be: Caleb's son Otho b. abt 1788 Caleb's son John b. abt 1789. Or one could be a son of Elijah (John D., Charles F. or Jarred HARN) although all three of these sons were probably born after 1790.

Cassandra DAVIS HEARN and (possibly) Sarah DAVIS HEARN, first wife of Elijah's brother Caleb HEARN. (Are they sisters?) The 3 other females could be: Elijahs dau. Amelia b. abt 1789 Elijah's dau. Rachel b. abt 1790 Elijah's dau. Henrietta b. abt 1790 Elijah's dau. Nancy b. abt 1790


Elijah and Cassandra have 7 young males living at home in 1810. None are confirmed. John D. HARAN is very likely a son of Elijah. He appears in Fleming Co. KY, 1850 census, b. in MD abt 1795. His wife is from VA and kids all born KY. He is a carpenter in 1850 and has son Elijah. (An apparently unrelated Joseph HARN lives in Fleming Co in 1810.) There is also Jarred HERN on the 1820 census, living next to both proven and presumed relatives of Elijah and Cassandra. He is the right age to be one of these males, above, and could be named for his grandfather, Garrard DAVIS. He may also appear in Wetzel Co. VA in 1850 with a son Elijah. Also, Elisha HARN is on the 1830 census next to a Lewis TOLL in Lewis Co. KY (formed from Mason Co. 1807). He was b. 1800-10, the right age to be one of the males above. Milton HARN is another likely son, as is Charles F. HARN and Alfred HARN b. 1802, who lived with his family in Harrison Co. KY, 1850 near 2 RAVENCRAFT families. His widow Sarah and children lived next to or with Mallery TOOLE in Lewis Co. KY in 1860. Finally, Emily FOXWORTHY, a granddaughter of John DAVIS and Hester HARN (below) through their daughter Dorcas Davis FOXWORTHY, wrote to Ellen D. HARN in 1901 that 3 HARN families

Elijah and Cassandra have 5 females living at home in 1810. The 3 older girls are clearly old enough to marry the TOLLE brothers (see next page) in the next few years. Two of these girls are probably Nancy and Rachel. Another is likely Cordelia who m. Isaac RAVENCRAFT 1816. Daughter Henrietta HARN m. Jonathan TOLLE in 1807 so she is not shown here. Amelia HARN m. Stephen TOLLE 1810 and since Stephen is shown with wife and 1 child on the 1810 census, Amelia is also not counted here. Maybe not all these children were born to Elijah and Cassandra. Or, some may have died young or are unknown to us.

lived in Mt. Carmel, Fleming Co. KY about 1885. So Elijah certainly left some male descendants in the area.

1810 LEWIS COUNTY CENSUS



John and Hester HARN DAVIS have 1 young male living at home in 1810. This is likely Eden H. DAVIS, born June 19, 1810 (census was submitted Dec. 1810). Their other son, John M. DAVIS will be born April 6, 1817.

John and Hester have 4 females living at home in 1810. Only 3 girls are known to belong to them. Another may have died young. Their known daughters are: Dorcas, Harriet O. and Mary A. DAVIS.

If the above records are correct, Elijah and Hester HARN were not neighbors in 1810, although Mason and Lewis Counties were next to each other. NOTE: Elijah HARNs census is in alphabetical order, so we cannot see his neighbors. But John DAVIS' census shows his neighbors. There is another John DAVIS in Mason Co. KY in 1810 with 4 boys under 15 and 3 girls 10-25 years old. Ages of these children don't match our John DAVIS well.

Possibly (?) Mary TOLLE, Elijah HARN's 2nd wife. If this is her, she has children from her 1st marriage, whose ages match those for Mary HERN on the 1820 census. TOLLE is likely her married name. Her 1st husband's name is unknown. She is not mother to the TOLLE brothers who married HARN girls. Their mother was Catherine HAMPTON.


Mason County KY countryside as it looks today



Henrietta HARN TOLLE, daughter of Elijah & Cassandra Davis HARN. She is Jonathan TOLLE's 2nd wife & was born in Frederick County MD



NOTE: Families on both these census records are shown in alphabetical order, so we cannot see who lived next to whom. The TOLLE families moved from Mason Co. to Lewis Co. in 1812.

This is likely Nancy (unkn) DAVIS of Frederick Co. MD, widow of Garrard DAVIS. She was born before 1765. She is living with one of her single sons, possibly Rezin DAVIS who married Nancy CLARY one year later, in 1811, and the slave named Jenny left to her in her husband's will (1804). Three people total. Nancy cannot be found on the 1820 census in KY or in IN. She may have died 1811-19 or was living in a relative's household and therefore wasn't named.



James O Cull

James O'Cull (below) was born in Uniontown, Pennsylvania on July 17, 1767. He

married Sarah Farrow in 1793 in Fleming Co., Kentucky. He conducted several recorded marriages as a Methodist minister according to the Mason County Marriage Abstract. Other marriages he officiated include: Nathaniel Horton to Elizabeth Thomas in 1819; Moses Phillips to Cordelia McDonald in 1819 or 1820; Benham Tolle to Nancy Applegate in 1823; Benjamin Suthard to Susan Delaney in 1823; Jacob Merril to Elizabeth Rumford in 1833; William Tolle to Phebe Thomas in 1834.

ELIJAH HARN ESTATE PAPERS, 1820

Elijah HARN died between 1814 and 1820 in Lewis Co. KY. When Shelley HARN MARTIN (a descendant of Elijah & Cassandra DAVIS HARN via John D. HARN) visited KY in 2012 to research her ancestry, she found and copied the appraised inventory and sale record of Elijah's estate. Elijah's death date isn't known but his estate sale was held June 9, 1820. The appraisers were Aaron OWENS, George MEANS and Matthias DAVIS. Mathias DAVIS was Cassandra DAVIS HARN's paternal uncle and the brother of Gerrard DAVIS Sr. Aaron OWENS lives next to John and Hester HARN DAVIS on the 1820 census and bought chisels from Elijah's estate sale.

It's obvious from the list of items sold that Elijah was a carpenter. Many other members of the HARN family were also in this line of work. Elijah's son John D. HARN and grandson Elijah HARN (2) were carpenters on the 1850 census. Lawson was a chair maker. We don't know Elijah (1)'s father's trade (John HEARN of Frederick Co, MD), but Elijah's brother Caleb was a builder. Caleb's son William A. HARN, grandson Grafton D. HARN & g.grandson Frank HARN (all of Dayton) were also carpenters.

The following list of items sold and the purchasers is pulled from the 1821 estate sale record visible on the following page. ("?" means the handwriting is not entirely legible.)

Stephen TOLLE was Elijah & Cassandra DAVIS HARN's son-in-law. He married their daughter Amelia HARN & after Amelia's death during childbirth he married their other daughter Rachel HARN. He had children by both. He bought: 2 saws, 7 shoats (?), wood, an oilstone, a screw & a coverlid.

Mary HARNE was Elijah HARN's second wife. Their marriage was likely the second for her too. She bought: a wedge, 4 wheels, loom tackling (?), a tub half-bushel, a kettle, a dutch-oven, 2 beds, a bunk, a chest, 2 buckets, a join (jar?), pewter tableware, a crock, a smoothing iron, 4 chairs, a plowbreak (?), a slay & harness, and 3 tubs (?). John P. HARN speculates she had to purchase her husband's belongings because he left no will. The proceeds would have gone to Elijah's estate to be distributed among all claimants, including Mary TOLLE HARN and Elijah & Cassandra DAVIS HARN's children.

John HARN is likely John D. HARN (born MD), Elijah & Cassandra DAVIS HARN's son. John was likely the oldest son of Elijah and Cassandra and was born in MD, before the large extended family migrated to KY. He was an infant or toddler upon arrival in KY. He was the administrator if Elijah's estate, along with Mathias DAVIS. He bought: a workbench, planks, bedstead timbers, a stone hammer, a square & compass, 4 chisels, a smoothing plane, living trees (?), a mill pick, a sieve, a slide & a number of planes. He was 25 years old at the time of the sale.

Jarret HARNE is likely Elijah & Cassandra DAVIS HARN's son. He bought: a mare, a kettle & horseshoes. He was 16-26 years old at the time of the sale.

Joseph TOLLE, brother of Stephen TOLLE (above) m. Charlotte BEAN. He bought a cow, calf & grindstone.


Reason DAVIS is likely Rezin W. DAVIS, the son of Matthias DAVIS. (The other Rezin DAVIS, a brother to Elijah's wife Cassandra DAVIS, moved to Indiana in 1812, 8 years before the sale, and stayed there.) Matthias DAVIS is one of the appraisers of Elijah's assets and a paternal uncle of Cassandra DAVIS HARN. Rezin W. DAVIS was Cassandra Davis HARN's first cousin. He bought a cow and some chisels.

John TOLLE is probably Elijah and Cassandra DAVIS HARN's son-in-law. He married their daughter Henrietta HARN. He bought several planes.

The identity of the following purchasers isn't known: John GILL bought a copper adze, a cross & compass, 2 small saws, a square & gauge, a roundshare & a cross. Naboth (?) PARKER bought horse gear & a bridle. John BREWER bought a loom. It's known that some members of the DAVIS family were in MD were weavers. William LEE bought planes, a hand saw & chisels. A Benjamin LEE lives directly next to Stephen & Rachel HARN TOLLE on the 1820 census. Thomas OSBURN bought 2 harnesses. Alexander DUKE bought a heifer, a square & a potters wheel (?). Gabriel PEEDE bought a calf, an axe, 2 planers, a knife & a hand vice. Phillip DARIEN (?) bought and auger, a bed, a pot, a kettle & bales. William DUGAN bought shoe maker tools & chisles. An Eleanor DUGAN lived directly next to Mary HARNE on the 1820 census. James CHANEY bought 2 plow irons & 3 gages. Samuel WHEAT bought 2 cleavers (?).

NOTES:

According to History of Lewis County Kentucky by Rev. O.G. Ragan pg. 277 (pub. 1912), in the April, 1823 term of the Lewis Co. Court: "Thomas. Marshall, Esq. gave information against John HERN in favor of Milton HERN, a poor orphan." This implies that John HERN, as the administrator of Elijah's estate, may have failed to adequately provide for his younger brother, Milton HERN, using the proceeds from Elijah's estate sale. The actual court records have not been found (as of 2013). The combination of this estate inventory and the above court record virtually confirm that Milton HERN is a son of Eliiah HARN.

John HARN was 25 years old at the time of the estate sale. Jarret HARN was 16-26 at the time of the estate sale. They were both recorded as making purchases.

Milton HARN was 9 years old and both Elisha HARN and Alfred HARN were between 10 and 20 years old at the time of the estate sale. Given their young ages, it isn't surprising they didn't purchase items from Elijah's estate.


1820 LEWIS CO. KENTUCKY CENSUS

The 1820 census shows several of the children of Elijah HARN and Cassandra DAVIS living in Elksburg Township, Lewis county, Kentucky. There were at least 4 marriages between TOLLE men and HARN women (daughters of Elijah and Cassandra Davis HARN). Stephen TOLLE (below) married Amelia HARN about 1810 in Mason Co. KY. Apparently, Amelia died in childbirth about 1812 and it is not known for certain if the child survived. Stephen then married Rachel HARN, Amelia's sister, in Lewis Co. KY in 1812. The 10+ year old boy in their household, below, could be Henry TOLLE, the child of Amelia and Stephen, although the dates do not work out exactly. Stephen TOLLE and Rachel HARN had 13 children, 7 of which were born by 1820 (below). This family moved across the Ohio River to Adams Co. OHIO between 1820 and 1830 and the parents spent the rest of their lives there. Rachel HARN TOLLE died before 1847, when Stephen married for the 3rd time and last time.

Nancy HARN married Jeremiah TOLLE (below) in Oct, 1813 in Lewis Co. KY and John DAVIS was the bondsman to that marriage. John DAVIS is probably the maternal uncle of the HARN sisters and husband of Elijah HARN's sister, Hester HARN. Nancy HARN and Jeremiah TOLLE had 10 children, 5 of which were born by 1820 (below). Nancy HARN TOLLE died before 1834, when Jeremiah remarried. Her maternal grandmother was also named Nancy, wife of Gerrard DAVIS.

Stephen, Jeremiah, Joseph and Jonathan TOLLE JR. (see bottom of page for information on Jonathan TOLLE Jr.) were brothers of each other and sons of Jonathan TOLLE Sr. and Catherine HAMPTON.

Cassandra Davis HARN, (Nancy & Rachel's mother) died before February 1814 since that is when Elijah married his 2nd wife, Mary TOLLE (below), in Lewis Co. Mary's relationship to the TOLLE men on this census is unknown. She may be their aunt but she isn't their mother. Elijah HARN died 1814 - 1819.



1820 LEWIS CO. KENTUCKY CENSUS, continued

The 1820 census shows Jarred HERN living in Elksburg Township, Lewis county, Kentucky, very near the HARN sisters and the widow of Elijah HARN, Mary HERN (his 2nd wife). This is the exact next census page as the one on the previous page of this document meaning Jarred HERN lived "within earshot" of the HARN / TOLLE families and Mary HERN. Jarred was b. 1794 -1804 making it highly likely he is a son of Elijah and Cassandra DAVIS HARN. If so, he was named for his grandfather, Garrard DAVIS. The female in Jarred's household was also b.1794 -1804 and the boys were b. 1804-1810 and 1810-1819. Perhaps all or some of the others in Jared's household are his siblings Elisha, Milton or Alfred, children of Elijah & Cassandra DAVIS HARN. This is possible since Elijah, had he lived, would have been only about 55 years old a the time of this census. Jarred was 16-26 years old, old enough to care for younger siblings.

There is also a **Jarad HARN** with wife Sarah (b. in MO. In 1815 making her 20 years younger than he) living in Wetzel Co. VA in 1850. This Jarad was b. in KY 1795, matching this 1820 census. The children of the 1850 VA census record of Jarad and Sara HARN are: Elijah b. 1833 in OH (interesting because some TOLLE / HARN families were living in Adams Co. OH at that time and Ellen D. HARN mentioned a Jarred HARN in OH), Esther b. 1836 in IA and William b. 1840 in IA. LouAnn Harn Cameron notes that some census takers abbreviated Indiana as "IA" suggesting Jared's children may have been born in IN. In fact, **Jared HERN** appears in Saluda, Jefferson Co, IN on the 1840 census, next to Milton HERN. It is unclear if the Jarred HERN in KY in 1820 (below) and the Jarad HARN in IN in 1840 and VA in 1850 are the same person but it is <u>very</u> likely. Note also the presence of a **John DAVIS** at the top of the page. This is almost certainly our John DAVIS, enumerated with wife **Hester HARN**.

On the 1830 census in Lewis Co. KY (township unknown), we find **Elisha HARN**, b. 1800-1810. According to birth year, he could be one of the children shown with Jarred HERN in the same county, below. If true, this Elisha could be Elijah and Cassandra's son. No other record of Elisha HARN has been found.

1830 AND BEYOND Offspring of Elijah HARN and Cassandra DAVIS

Elijah's 2nd wife **Mary HERN** / **HERANE** lived near **Mathias** and **Reason DAVIS** in Lewis Co. in 1830. We don't know if she and Elijah had any children in the short time they were married. But since Elijah was about 55 at the time of his death, and he and Mary had been married for at least a few years, it is possible. Clearly, Elijah had a number of sons with Cassandra DAVIS.

Stephen and Rachel HARN TOLLE lived in Adams Co. Ohio in 1830 with 9 boys and 3 girls in their household. Nearby is William DAVIS Jr., who may be the same William DAVIS seen near Stephen and Rachel HARN TOLLE (and nearer Jarred HERN and Rezin DAVIS) in Lewis Co. KY in 1820. Stephen & Rachel were still in Adams Co. OH in 1840 & 1850. Three of their children married DAVISes, identities unknown. Rachel HARN TOLLE died bef. 1847, when Stephen remarried.

Jonathan and Henrietta HARN TOLLE lived in Bourbon Co. KY in 1820 and 1830 and in Harrison Co. KY in 1840 and 1850. Some of their children went to Missouri and Indiana.

Jeremiah and Nancy HARN TOLLE lived in Lewis Co. KY in 1830. Nancy died before 1834 when Jeremiah remarried. One of their 6 children (5 boys and one girl), Horton TOLLE, lived in Lewis Co. KY in 1838. The others are so far unaccounted for. Jeremiah may appear on the 1830 census in Lewis Co with no wife and 5 children about 25 households away from Elisha HARN (below), suggesting Nancy HARN may have died prior to 1830. Or there could have been 2 Jeremiahs.

Isaac and Cordelia HARN RAVENCRAFT lived in Fayette Co. Indiana in 1820 with 3 boys and 2 girls, right between Rezin DAVIS and Francis DAVIS (sons of Garrard & Nancy DAVIS). This Rezin is not Rezin W. DAVIS who lived next to Jarred HERN in Lewis Co KY in 1820. The Rezin DAVIS in Indiana is Cordelia Harn RAVENCRAFT's maternal uncle because Cordelia HARN's mother, Cassandra Davis HARN is Rezin DAVIS' sister. Cordelia was 16-44 years old in 1820 and her husband Isaac RAVENCRAFT was probably a blacksmith. By 1830, Isaac and Cordelia HARN RAVENCRAFT were in Fleming Co. KY, still with 3 boys and 2 girls. Isaac was 30-40 years old and Cordelia was 40-50 years old. They lived very near Samuel, Alexander and Thomas FOXWORTHY. A Samuel FOXWORTHY married John and Hester HARN DAVIS' daughter, Dorcas DAVIS (2) in Fleming Co. KY, 1830. In 1850 Cordelia HARN RAVENCRAFT, now 57 years old and widowed, lives in Lewis Co. KY with her son James, a 21 year old blacksmith.

Elisha HARN lived in Lewis Co. KY in 1830 near Lewis & Jeremiah TOLLE. Elisha and wife were born 1800-1810, making him the right age to be a son of Elijah and Cassandra Davis HARN. (The Elisha HERRON in Hopkins Co KY in 1840 is probably (?) not the same person.) In 1830 Elisha & wife have a boy & girl, both born 1825-30. Lewis TOLLE has not been identified. Neighbor Jeremiah TOLLE may be the husband of Nancy HARN, a daughter of Elijah and Cassandra Davis HARN.

Jarred HERN lived next to Mary HERN and the HARN / TOLLE families in Lewis Co. KY in 1820 and in Jefferson Co IN next to Milton HERN in 1840. Milton is 2-9 years younger than Jarred. Jarred was known to Ellen Dorcas HARN and is very likely a son of Elijah HARN & Cassandra DAVIS. If so, his grandfather was Garrard DAVIS (namesake). He is very likely in Wetzel Co. VA in 1850. Milton HARN is described further, later in this book.

John D. HARAN lived in Fleming Co. KY, 1850 census, b. in MD abt 1795. His wife Susannah NORMAN is from VA and kids all born KY. He is a carpenter in 1850. He married 1819. Their first child is likely Lawson HARN. Other children were Elijah (2) b. 1824-25, Margaret b. 1823, Louisa b. 1830, Sarah b. 1836 and John b. 1840. In 1840 a John HERRON appears on the Fleming Co, District 1 census. Ages of John, wife and kids match John D. HARAN 1850 census exactly. In 1840, John lives next to (with?) Lawson HERRON born 1810-20. See following pages for marriage record of John HARAN's son, Elijah HARN, to Margaret Lightfoot. In 1830 a John HERREN lives near Charles F. HARREN in Fleming Co KY. Ages of John's children match later records. Both John and Charles F. were born 1790-1800. Charles F. has 4 daughters & 1 son in 1830. He may be another son of Elijah 1. He may live in Montgomery Co. IN in 1840.

ALFRED HARN, likely son of Elijah HARN 1

ALFRED HARN

is on the **1840** census in Bourbon Co. KY <u>living near Daniel TOOLE</u>. Alfred is born 1800-10.

There is an older man in the household b. 1790-1800 (father/father-in-law?) One male child was b. 1820-25, and 2 males were b. 1825-30 Alfred's wife was b. 1800-1810.

One female child was born 1820-25 and another 1830-35. The ages of these children match later records for Alfred's family, below, exactly.

ALFRED HARN

is also on the **1850** Harrison Co. KY Census <u>living near 2 RAVENCRAFT families</u> (Isaac Ravencraft, husband of Cordelia HARN died before 1850. Cordelia HARN RAVENCRAFT appears on 1850 census in Lewis Co.) Alfred was b. VA about 1802 (birth state is shown as KY in later census records of his children so this VA notation is likely an error?) Wife is Sarah (Hennis) b. 1802 KY

Kids are:

Wm b. 1830 KY (this is likely James Wm.) Mary b. 1832 KY Oliver b. 1827

The family of this **ALFRED HARN**, minus Alfred himself, is also on the **1860** Lewis Co. KY census living <u>directly next to the family of "Mallery"</u> <u>TOLLE</u> (possibly in the same household). This somewhat suggests this HARN family belongs to us due to 4 earlier HARN / TOLLE marriages. Sarah is head of the HARN household, b. 1802 Kids are:

Mary E. b. 1835 appears unmarried

James W. b. 1830 (W = William from above?) appears unmarried.

Note: There is an Alfred **HEARNE** living very near Clement and Cannon HEARNE (slaveholders) in Bourbon Co. in 1830. William HEARNE's 1902 book claims this Clement descends from Wm. HEARNE ("The Merchant") of the Eastern Shore MD (not our family). Alfred and Cannon may be sons of Clement, according to ages. However, Clement's will names Cannon but not Alfred. Clement b. 1760-70, Alfred b. 1800-10. On the 1830 census, Alfred has 3 boys born before 1830, which matches our Alfred. See next page for David HAMMONDS thoughts on Alfred HARN.

SARAH HENNIS' FAMILY WAS FROM FREDERICK CO. MD, ALTHOUGH SHE WAS BORN IN LEWIS CO. KY

These 3 records somewhat point to Alfred HARN belonging to us. But a minor problem is the listing of his birth state as VA on the 1850 census. A major problem is the existence of this same Alfred HEARNE in Bourbon Co. KY in 1830 very near Clement and Cannon HEARNE who are definitely not ours. But Alfred's birth year and proximity in later years to TOLLEs & RAVENCRAFTs in Lewis Co. suggest he is a son of Elijah & Cassandra Davis HARN, as do his children's burial places next to other HARNs who are believed to be descendants of Elijah and Cassandra HARN.

The marriage record of Alfred HARN's son, Oliver (above) is:

of Lewis Co, KY, aged 24 yr. aged 23 yr., married at Mrs. Mary Cooper's by Jedediah Foster; James B. Certificate of Marriage- This is to certify that on the 4th day of November 1852 the rites of marriage were legally solemnized by me, between Mr. Oliver A. HARN of Lewis County, Kentucky, aged 24 and Miss Mary F. COOPER of Mason County, Kentucky aged 23 at Mrs. Mary Cooper's in the County of Mason in the presence of Mrs. Mary Cooper, George Pollitt, James Beckit and others. Mr. HARN was born in Bourbon County, Kentucky and Miss COOPER was born in Mason County, Kentucky. Signed: November 5th, 1852 by Jedediah Foster, Pastor M. E. Church. Oliver HARN lives with his wife and children: Sumpta C. (female b. 1854), Benjamin F. (b. 1856), George A. (b. 1859) in Lewis Co. KY in 1860. NOTE: This marriage record confirms that the 1830 Alfred HEARNE in Bourbon Co. is the same person as the 1850 Alfred HARN in Lewis Co.

David R. HAMMOND, a descendant of the Alfred HARN described on the previous page, sent the following email to John P. HARN, explaining his take on the connection of Alfred HARN to Elijah and Cassandra Davis HARN.

Dear John

There is no doubt that Alfred Harn who married Sarah Hennis in Lewis County Dec 12, 1823, and the Alfred Hearne/Harn reported in the Bourbon County Federal censuses 1830 and 1840 are the same person. The relationship, if any, of Alfred to the nearby Hearne families in the 1830 census remains unclear, but I believe it is just a coincidence, with the enumerator just assuming the same spelling for all families. Although I have not yet turned up any land records for Alfred in Bourbon or Harrison Counties, the ages of children listed in his household fit in all three censuses. Alfred's son (and my 2-gt grandfather) Benjamin Hennis Harn married Susan Catherine Butler in Bourbon County Mar 6, 1845, with bondsman identified as Benjamin and Alfred Harn. This makes sense as Susan's father, Moses Butler, died in 1829 and Susan's brothers Henry Alexander and Stephen Waller were not old enough to act. Steven Waller Butler does serve as bondsman later for the marriage of his sister Sarah Elizabeth to Joseph Hall in June 1853, again in Bourbon County. Also important: Susan Catherine and her widowed mother Margaret Miller Butler are living with Margret's brother Jacob Miller in the 1840 census very close to Alfred Harn in Bourbon Co. So the presence of our Alfred in Bourbon and later Harrison County is well defined. The older male reported living in Alfred's household on the 1840 census could not be his father-in-law Benjamin Hennis as Benjamin was born about 1760; however Benjamin did die in Bourbon County Feb 23, 1847. His name is inscribed on the plaque attached to the wall of the courthouse steps commemorating Revolutionary War soldiers who died in Bourbon County. It's unclear when Benjamin's wife Dorcas, b. ca 1763, died but probably after 1840.

On the 1850 Harrison County census Alfred indicates his birth state as Virginia. This has long been a point of confusion but I believe he just misstated—the Kentucky region was a part of Virginia in the 1700s and his declaration merely a holdover perception of that earlier jurisdiction. On the 1880 census three of Alfred's children, Benjamin, James and Mary, all list their father as being born in Kentucky (the other children--Angeline and Oliver--are deceased prior to 1880). Alfred is missing from the 1860 census as he died in Lewis County February 1856. My 2nd gt grandfather Benjamin Harn administered Alfred's will in Lewis County. I believe Alfred and his family, including Benjamin & Sarah, moved back to Lewis County in the early 1850s. Other parts of his extended family moved to the Lewis/Mason/Fleming area as well--Susan Catherine's mother Margaret Miller Butler, and Susan's brother Stephan Waller Butler. Stephan marries Amanda Proctor in 1854 in Fleming County. Alfred' son Oliver marries Mary Francis Cooper in Mason County in 1852.

Alfred & Sarah's children James (married Eliza Martin) and Mary Elizabeth (never married) are buried at the Mt. Carmel Cemetery in Fleming County, along with a number of other Harns, most of whom are descendents of John D. Harn. Benjamin & Susan Catharine are at Flemingsburg Cemetery. Alfred's wife Sarah Hennis Harn died at Mt. Carmel in 1868: shortly after her death Benjamin sells 77 acres on Philips Creek in Lewis County approximately 2 miles southwest of the village of Tollesboro, but with specific reservation of 1/8th of acre to remain as a family burial ground. I believe that this tract is where Alfred & Sarah, and possibly other early Harn family members, are.

Obviously definitive proof of Alfred being a son of Elijah Harn (1) remains lacking, but I think the circumstantial evidence does point in that direction. Proof will likely have to come from DNA matches.

THE Y-CHROMOSOME DNA TEST FOR MALES

If two males take the same Y-DNA test, the results can be compared with each other. If there are enough similarities between the two test results, we can say those two males share a common male ancestor, and approximately how many generations ago that common ancestor lived. Or, if the two test results are not similar, we can say the two males do NOT share a common ancestor. The test will not tell WHO the ancestor is. It will only show whether or not two testers have a common ancestor and roughly how far back that common ancestor lived.

Since only males have Y chromosomes, only men can take this DNA test and only male common ancestors can be discovered via this test.

On the right side of this page are the Y-DNA test results for John P. HARN, a descendant of John and Dorcas DAVIS HEARN of Frederick Co. MD. The lab compared John's DNA to every other male in their database who had also taken the Y-DNA test.

The results, on this page, show that Steve Harn REDMAN and Alan Duane HARN share a common male ancestor with John P. HARN. This was predicted by other, traditional research. The three of us already knew we shared a common male ancestor (John HEARN who m. Dorcas DAVIS). The DNA tests proved that was correct.

But news to us was that Daniel Phillip HEARN also shares a common male ancestor with the three of us (John P, Steve and Alan HARN).


Ellen Dorcas HARN's brother, George Upton HARN wrote the following to Eden H. DA-VIS in 1859. (The blue text was inserted by John P. HARN in 2013): "The old tree (the original HARN immigrant) had three branches, two sons (Michael HEARN of Howard Co MD and John HEARN of Frederick Co MD) and a daughter (identity unknown). The second son (Michael HEARN b. abt 1735) had, I believe, one son, Isaac, whose descendants are chiefly in Howard County, Maryland and spell their name Hearne."

Because Daniel Phillip HEARN is a descendant of this Michael HEARN, the Y-DNA test results, shown at right, confirm George Upton HARN's account and tell us that John HEARN of Frederick Co. MD (m. Dorcas DAVIS) is the brother or first cousin of Michael HEARN of nearby Howard Co (part of Ann Arundel Co in the mid-1700's). Thus any information on the ancestry of Michael HEARN is automatically also information on the ancestry of John HEARN m. Dorcas DAVIS. This is the power of DNA testing.

Since John P. HARN (and others) Y-DNA results are already on record, they can be used to prove whether or not any of the HARN males in KY (Alfred, John D, Milton, Jarred, Elisha) are in fact children of Elijah HARN (1). How? If a known male descendant (must be a direct line of male-to-male descendants) of Alfred, John D, Milton, Jarred or Elisha also takes the 46-marker Y-DNA test and their results match John P. HARN's, it will prove that the new tester is positively descended from Elijah HARN (1), and thus also from the early HARNs of Frederick and Ann Arundel Counties, MD.

NOTE: James Batson HEARN of VA and James HEARN of GA also took the 46-marker Y-DNA test. They are known descendants of William HEARNE "The Merchant" of Maryland's Eastern Shore. Their DNA results DID match each other (as expected) but DID NOT match John P. HARN, Steve Harn REDMAN or Alan D. HARN. Thus the Western Shore HEARNS (John HEARN m. Dorcas DAVIS and Michael HEARN) are not related to Wm. HEARN "The Merchant" of the Eastern Shore of MD.

NOTES: MRCA = Most Recent Common Ancestor. Steve Redman's father was a HARN but his surname was changed via adoption. Steve, like John P. and Alan D., is in an unbroken line of male HARNs. A Y-DNA test costs \$150 and does not require a blood sample. The DNA is collected via a saliva sample, all done by post, and can be ordered at Ancestry.com (membership NOT required).



Margaret for **LAWSON HARN** to be born. Because Lawson was b. 1821, he couldn't be a son of Elijah, who died before 1820. Milton HARN, likely son of Elijah HARN and Cassandra DAVIS

On the 1840 census a **Milton HERN** lived directly next to (probably with) **Jared HERN** in Jefferson Co. IN. He was born 1800-1810. His wife was also born 1800-1810. They have one boy and one girl, each born 1835-40. Given his birth year and the ages of his children, Milton probably married about 1830. Milton and Jared HERN are likely brothers, Jared being 2-9 years older than Milton.

A Milton HEARN married Eliza Jane TUCKER 1 Dec 1831 in Vigo Co. IN.

It isn't known if this is the same Milton as above. But Milton's wife was named Elizabeth, as shown below.

On the 1850 census a **Milton HERRON** lived in Township 1SR2 West, Brown Co. IL. He was a farmer in 1850 and was born 1812 in KY. His wife, **Elizabeth** was born 1813 in KY. Their children were:

Eliza b. 1838 in IL (or possibly PA)

Henry b. 1846 in IL

Calvin b. 1845 in IL

Harriet b. 1847 in IL.

On the 1860 census a **Milton HERN** lived in Lewis Co. KY. He was a farmer and was born 1811 in KY. He can't read or write. His wife is **Louisa**, b. 1831 in KY. She also can't read or write. Their children were:

Henry b. 1844 in IL

Calvin b. 1846 in IL

Harriet b. 1849 in IL

Daniel b. 1857 in **KY**.

Obviously, the 1850 and 1860 families are the same. However, the wife is different.

It appears Milton moved from Brown Co. IL to Lewis Co. KY sometime between the birth of Harriet in IL in 1847-49 and the birth of Daniel in KY in 1857.

Perhaps Milton's first wife, Elizabeth died in IL sometime after the birth of Harriet there 1847-49. Then Milton moved his family to Lewis Co KY, where he had relatives, and remarried to Louisa, a girl 20 years younger than he. Milton and Louisa had a child of their own, Daniel, born 1857 in KY. Or, it is possible that Daniel was born to Louisa before she married Milton since Daniel was born when Louisa was 26 years old.

On the 1870 census, a **Milton HARN** lived in Mowers Township, Lewis Co. KY. He was a farm laborer and was born 1812 in MASON CO. KY (the census enumerator wrote the county as well as the state of birth). His wife is **Louisa**, b. 1832 in Mason Co. KY. Milton cannot write and Louisa cannot read or write. Their children were:

Cynthia b. 1852 in Lewis Co. KY Daniel b. 1856 in Lewis Co. KY Martha A. b. 1864 in Lewis Co. KY

The existence of daughter Cynthia HARN b. in Lewis Co. KY in 1852 suggests Milton married Louisa about 1851, when Louisa was about 20 years old (if Milton is the father of Louisa).

Also on the 1870 census, living directly next to (or with) Milton and Louisa HARN, is **Calvin HARN**, Milton's son. Calvin was born 1847 in IL. His wife is Mary, b. 1848 in Lewis Co. KY. They have a daughter, Parthenia, b. 1869 in Lewis Co. KY.

Milton HARN is assumed to be a son of Elijah HARN and Cassandra DAVIS because:

He was born 1811-12 in Mason Co. KY He lives next to or with Jared HARN in Jefferson Co. IN in 1840.

He moves back to Lewis Co. KY about 1850,

where there were other relatives of Elijah HARN and Cassandra DAVIS.

He is mentioned together with John HERN in Lewis Co. Court Records, 1823, according to "*History of Lewis County, KY*" by O.G. Ragan, pg 277.

In 1901 Ellen Dorcas HARN (b. 1829, d. 1930, a grandniece of Elijah and Hester HARN through their brother Caleb) received a letter from Emily FOXWORTHY regarding Emily's family in KY. Emily FOXWOR-THY was a granddaughter of John and Hester HARN DAVIS. Emily's parents were Dorcas DAVIS (2) dau/of John and Hester HARN DAVIS, & Samuel FOXWORTHY.

The following is taken from Ellen D. HARN's manuscript:

In a letter dated Mt. Carmel, Kentucky, Sept. 7, 1901, she (Emily Foxworthy) says: My mother (Dorcas Davis Foxworthy) died January 7. 1871, and my father, 1875." She also adds concerning her relatives, *Elijah HARN's family, There were three families of that name* (HARN) living in this county (Fleming) some ten or more years ago (about 1885).

Mary Frances COOPER HARN (lower left) was one of 7 children born to Isaac COOPER and Mary VALEN-TINE. Mary married Oliver Ashford HARN s/o Alfred & Sarah HENNIS HARN, December 13, 1823 in Vandeburg, Lewis County, Kentucky. Mary was the Mother of Sarepta C., Benjamin Francis, George Wm, John & Mary Frances HARN.

What the relationship was I never knew. The men are all dead and their families scattered." (sic)





Dear Mr. Harn.

It was a great pleasure to receive your letter of Oct. Lo and learn so much that I did not know about our anestors and you may be sure that I wish to cooperate in every way possib e in order that the maniscript in question may be brought up to date and

that the maniscript in question may be brought up to date and published at an early date. The following genealogy of my branch of the Harn family is to the best of my knowledge:

Lawson Harn and family migrated into Kentucky near Fleming-burg from an eastern state the I never learned the name of the state it was probably Maryland as you stated. Lawson who was my grand—father had three boys and four girls whom were born in the order named John M. Betay. Robert, Guann, Evange and Magric and Education. named John H. Betsy, Pobert, Susan, Evangelene, Maggie and William Harn respectively. John M who was my Father being the oldest and

William the youngest.

Shortly before the Civil War John and Robert being bitter against slavery left their home in Kentucky and came to Indiana, polis, Ind., where they remained until War was declared. Then when Presedent incoin called for ninty day troups they both enlisted John in theilth and Robert in the 7th Ind Vol Reg. At the expiration of the ninty day period they both reenlisted in their respeccaptured during the later period and served five months and eighteen days in the rebel prison at Salesbury, R.C. from which he captured long after leaving the long after leaving the service. The boys returned to Indianapolis at the close of the Was and John married Esther Call of that city. Robert also married but I am unable to recall the ladys name. Esther Call was my mother.

About a year after the War ended Lawson Harn and family came North and settled in Brownsburg, Ind., but a short time later the entire Harn family including John and Robert and Wives loaded into covered wagons and started west. The party became disheartened after William accidently shot and killed himself while removing a shotgun from one of the wagonsin western Illinois and only got as far west as Jones County Iowa where they remained but a few months returning east to Rossville, Ill., where Jennie Agnes Harn my slder sister was born Dec 27,1367. The march east was only halted temporarily and then continued to Brownsburg, Ind., where they finally settled to live. Lawson being a cabinet maker started a place of business and remained in that city until his death in 1375 at which time the youngest daughter Maggie also died. "Hello Cousin Shelley. Great minds think alike. I have been trying to track down a Lawson heir for some time. It's interesting that you found me. I am indeed the great grandson of Elijah Harn (2) who was the brother of Lawson Harn. Lawson was born around 1820 and Elijah (2) was born in 1826. Lawson married Marry Ann Overley on November 14, 1838 and they are in the Fleming County 1840 census records. I assume you have the children's names. Never could find Lawson or Mary Ann's death records. Lawson must have migrated to Indiana after 1840. John (D) Harn and Susannah Norman were Lawson and Elijah (2)'s father and mother. John (D)'s father was indeed Elijah Harn (1) who came to Mason County around 1800 from Maryland. Lawson's marriage record is in the Fleming County Courthouse. Lawson and Elijah (2) also had a brother named John (John D. HARN Jr.) who I think migrated to Indiana as well.

Enough of that, I would very much like to meet you. I'll be around anytime this summer. I live in Hillsboro, KY. I'll be glad to show you around. The farm that my great grandfather (Elijah 2) had is still there. The log house has been torn down, but I remember going to visit my grandfather, William well. I had been trying to find someone in IL who was kin to the HARNs but had struck out. I did find someone in North Carolina but haven't contacted them yet. I'm really excited to be able to talk with you and am looking forward to meeting you. Not many of my generation left. I have three cousins and a sister left. (My daughter) Kristin lives in Lexington, but perhaps she can be hear as well. I want her to meet you, because we all go back quiet a few years." (Shelley got to meet Norman's son Brad and wife Sandra, but not his daughter Kristin)



Alfreda POTRAFKE says:

"I can remember Dale's (Edwin Dale) grandma **Nelle** (who lived to 102) saying how it was hard to believe all the things she had seen invented in her lifetime. The airplane being one... as they made her fly at 96 for the first time! Ha! Her son, who lived in Ohio, and her daughter, who lived in Texas, would each have her half the year and they would meet half way every year to switch her, until one year, something happened and they couldn't meet, so she had to fly. I can remember she was so mad (scared) about it! I don't really have much about Bill Hildebrandt; unfortunately, he died when I was five. I actually knew Grandma Nelle; my kids even knew and remember her. One other thing I can tell she was in good health up through her 90's. She guilted by hand into her 90's. Her hearing was bad, but that was about the only thing I remember being wrong with her. Bill worked at the Chair Factory in Williamsburg, Ohio, then after working there, he was a "Wood Worker" at home in his own workshop; he was very good at caning chairs. My grandfather (Herman F. Potrafke) was a Carpenter/Contractor, who also had his own business and built many homes and businesses in Clermont County Ohio, so they knew each other. My grandpa always spoke highly of my husband Dale's grandpa. According to Eva Gabbard-Hildebrandt, during a visit January 25, 2001, Tracey Pearl Hilderbran, brother of William Adam Helterbran, son of John and Harriett (Tolle) Helterbran drowned. They were in a wagon of some kind and went into deep water and he drowned. She believes maybe William was with him at the time he drowned because he spoke of it a lot in his older years while he was in a nursing home. But I can't prove this story, it's hear-say. The name Hildebrandt has many different spellings, and in 1971, Grandma & Grandpa Nelle legally changed the spelling of their names (which I believe was Helterbran) and all their kids birth certificates to "Hildebrandt". I have the legal document from when she did this. I also knew Phil Hildebrandt VERY well. I could write a book on him alone. He was the neatest man and the best father-in-law a woman could EVER hope for. He was a wonderful grandpa to our kids too. He was one of a kind. I still miss him so bad some days; I loved him to death."



Elijah was on the voter lists of Winchester Township, of Adams Co, Ohio, and on all census records 1850 - 1880. When Rachel DAVIS died, Elijah married again to Elizabeth Jane DAVIS. He was a farmer, and resided in Jaybird in Adams Co. He died 21 Oct 1899 at the age of 80 years and 13 days and was buried in Unity Cemetery, Oliver Township, Adams Co. Administrator of his estate was Elizabeth J. TOLLE & Stephen A. Tolle (a son). Witnesses were F.D. Bayless and A.C. Sparks. The final distribution was published on 30 Mar 1900. The children of Rachel Jane (Davis) and

Elijah Tolle were: MILTON PERRY TOLLE born 31 Jul 1843; married Adaline Wilson Black 29 Nov 1866. JOSIAH H. TOLLE (TOLL) born Jul 1845; married Lucinda Smalley. THOMAS L. TOLLE born Mar 1847; married Martha A. Davis. EUPHEMIE KATHERINE TOLLE born ca 1849; married Hugh Norman. STEPHEN A. TOLLE born 1 Sep 1851; married Anna Belle Wilson.

1830 AND BEYOND

Offspring and extended family of John DAVIS and Hester HARN

John DAVIS & Hester HARN moved from KY to Hanover Township, Shelby Co. IN about 1825-28. John's brother, Rezin DAVIS, had been there for several years prior and owned land. John and Hester HARN DAVIS appear there on the 1830 census together with Rezin, James and David DAVIS (see next page).

A sister of Rezin, John, Charles and Nathan DAVIS, **Eleanor DAVIS**, married **Joseph SPURRIER** in MD before the DAVIS family migrated to KY. Eleanor died in KY and Joseph remarried Catherine RANKIN there in 1817. Benjamin DAVIS, brother of Joseph's first wife Eleanor, was bondsman. Joseph and Catherine RANKIN SPURRIER appear in Lewis Co in 1820, living near Reuben TOLLE (a brother-in-law of Elijah and Cassandra Davis HARN's daughter). Although Eleanor DAVIS died before her brothers moved to Shelby Co. IN, her children apparently traveled there with their father, Joseph SPURRIER, their DAVIS uncles and their step-mother. Therefore, some children surnamed SPURRIER in Shelby Co. IN are nieces and nephews to the DAVIS brothers above. A **Lucinda Jane SPURRIER** married the son of Rezin DAVIS, **George Walker DAVIS**, in Shelby Co. IN in 1835. This was a marriage between 1st cousins. (George Walker DAVIS is in DD. Palmer's direct line via his 2nd wife, Delila SNIDER.) Eleanor DAVIS and Joseph SPURRIER also had a son named **Garrard SPURRIER**, the given name of Eleanor's father and this Garrard SPURRIER also lived in Shelby Co. IN. Note: A nephew of Hester HARN (William A. HARN) married Ruth SPURRIER (the niece of Joseph SPURRIER) in Frederick Co. MD in 1830. (William A. and Ruth SPURRIER HARN are in John P. HARN's direct line.)

The 1830 Shelby Co. IN census shows **John DAVIS** (birth year 1760-70) living near his brother **Rezin DAVIS** (birth year 1780-90) a **David DAVIS** (birth year 1800-10, identity unknown) and a **James DAVIS** (birth year 1800-10, a possible son of Francis DAVIS?) in Hanover Township. This is our John and Hester HARN DAVIS because the ages of their children match up with other records. **Hester HARN's** birth year is 1770-80 on this census. See next page for the 1830 census image.

On the 1840 Shelby Co IN census we find, all in Hanover Township:


Many of these DAVISes are buried in the DAVIS FAMILY CEMETERY in Morristown, Shelby Co IN, which apparently originated with the burial of the freed slave Jenny (mentioned in the will of Garrard DAVIS in Mason KY in 1804). Jenny traveled to Shelby Co IN with Garrard's son Rezin DAVIS (1). She, and John and Hester Harn DAVIS who are also buried there, have no headstone.

A John DAVIS bought a parcel of land in Shelby Co. IN from Robert and Mary BENEFIEL in 1833. Only John's name is recorded. Hester HARN died in 1831. It is unproven this John was our John.

The 1830 Census in Hanover Township, Shelby Co. IN shows <u>John and Hester Harn DAVIS</u> living near <u>Rezin DAVIS</u>, <u>David DAVIS</u> and <u>James DAVIS</u>. The names are listed alphabetically so we cannot see exactly how closely they lived to each other.



The identities of **James DAVIS** and **David DAVIS**, above, are unknown. On this record, both were born 1800-1810. Both appear to be married but only one young child between them suggests they are in their early 20s. David's wife is 15-20 years old. A brother may live with James.

In 1820 in Fayette Co. IN, a **James DAVIS** lived near **George DAVIS**, **Francis DAVIS** and **Charles DAVIS** (Francis and Charles were brothers to Rezin and John, above, and sons of Gerrard and Nancy DAVIS of KY). On the 1820 census both James and George were born 1775-94 so the 1830 James (above) and the 1820 James DAVIS in Fayette Co, IN may be different people.

James and David may be sons of Charles or Francis (who are brothers of John and Rezin DA-VIS above). **Francis DAVIS** goes missing after the 1820 Fayette Co. census. James and David, above, are not children of Rezin or John DAVIS, above.

1859 CORRESPONDENCE BETWEEN EDEN H. DAVIS

Reprinted from the HARN family history manuscript by Ellen Dorcas HARN, sister to George Upton HARN, written over a period of 30+ years starting in the late 1800's. Blue text notes were inserted by John P. HARN in 2011. Ellen was a granddaughter of Caleb HARN, who was a brother of Hester HARN m. John DAVIS and also of Elijah HARN m. Cassandra DAVIS. Both LouAnn Harn CAMERON and John P. HARN, researchers of this book, descend from Caleb HARN: LouAnn from Caleb's 1st wife Sarah (Sallie) DAVIS and John from Caleb's 2nd wife Charity DUVAL.

EARLY AUTHENTIC HISTORY OF THE HARN FAMILY

In my (Ellen D. HARN's) research for data of early HARN history among the papers now in my possession, of my brother George Upton, I find an unfinished letter never sent to the person to whom it was written. From the paragraph in this letter referring to his religious convictions I come to the conclusion that it was intended for Eden H. Davis, (whose mother was Hester HARN DAVIS, wife of John DAVIS of Gerrard and Nancy DAVIS) of Shelbyville, Indiana. Mr. (Eden H.) DAVIS, I am informed, was a Universalist. It seems from the trend of my brother's letter that he and Mr. Davis were then in correspondence in regard to the kinship of the two. I surmise the reason why this letter was never finished and sent was because of the exciting times just previous to the Civil War and the organization of the Republican party, in which my brother (George Upton HARN Sr.) took and active part. The letter is given entire as follows:

Wooster, Ohio, July 11, 1859

Dear Sir (Eden H. DAVIS):


Yours of the 8th is received. I thank you for your kindness, and hope we shall have no cause to regret our relationship as well as our growing acquaintanceship. Your great grandfather (likely Daniel HEARN of Anne Arundel Co. MD although George Upton HARN did not know his name) was my great-great grandfather. He was the first of our name I have been able to trace in America and he came from London and was of Cymbro of Welsh decent of the Old Celts, or Britons, of Ceasar's notice. These are the facts, I believe, and harmonize with Webster's philology of our name. This old tree had three branches, two sons (Michael HEARN of Anne Arundel Co MD and John HEARN of Frederick Co MD) and a daughter (this daughter's identity is unknown). The second son (Michael HEARN b. abt 1735) had, I believe, one son, Isaac, whose descendants are chiefly in Howard County, Maryland and spell their name Hearne (this was confirmed through traditional research and DNA testing in 2009). The daughter left an heir, Overton HARN, of Middletown Valley, Frederick County, Maryland (unconfirmed). He (Overton HARNE) has a son Horatio who was elected to the legislature from Washington county, that state. Overton, I learn, is ignorant of how he is related to the family, and, indeed, when I last saw him, twelve years ago, did not know that we were related at all. (Overton's connection is still unconfirmed as of 2011).

Horatio, his (Overton's) son, knows and lives in Hagerstown (MD). My grandfather, Caleb (HEARN), was the oldest son of your grandfather, John (HEARN of Frederick Co. MD, m. Dorcas DAVIS). He (Caleb) had four sons and two daughters, my father (John HARN, son of Caleb) being the eldest, and I am the eldest of fourteen children, nine only of whom are living, three sons and six daughters. My mother and two sons reside near Mr. Airy, Frederick county, Maryland. Four sisters are in that vicinity and two in Minneapolis, Minnesota, one (Sarah HARN), there being married to a Free Will Baptist preacher, named A.D. Williams, a clever fellow and a finished scholar, of celebrity in that denomination. My father is dead since '52.

I am a married man, having a wife and two children, sons (one is also named George Upton HARN). One seven years and the other forty one days old. We have lost two children between, one son a daughter. If I live to see the 30th day of the present July I will be thirty-nine years old. I was reared upon a farm in Frederick county (as was his younger sister, Ellen Dorcas HARN), took to preaching when I was grown, have traveled a great deal east and west, have been in your place I think.


In faith, I differ very materially with you, being as I am of the Orthodox belief, and strongly Baptistic in the practice of the ordinance of Baptism. The people I cooperate with wear no human names or titles, but call each independent church, or congregation a Church of God, at the place where it assembles. I do not spend now the whole of my time in the ministry, but am partly engaged in the show business in this place of 3000 population. I was a Whig as long as that party lived, and although at one time my father was a slave holder I was what was denominated a Wooley Head Whig, a contra-distinction to the SILVER GRAY faction of that party. I have always been rather active in politics but never sought an office till last fall. I was a candidate for the Congressional nomination in this, the 14th District of Ohio. There were nine candidates in convention, four from this county, and by my influence Gen. Spink, now dead, was nominated and then elected by 2100 majority. I am a candidate to fill his vacancy and flatter myself that my chances are good for the nomination, although I am contesting the ground with the Lieutenant Governor of this state. He (Martin WELKER) resides in this village and is a good man, but has a perfect mania for office.

You have an own cousin, Isabella HARN (daughter of Hester HARN's brother, Denton HARN), at St. Marys, in this state (Ohio). She has two sisters, married, residing there and at Sidney (Ohio). I have two cousins, HARN (Grafton Duval HARN and Ira Baker HARN) at Dayton (Ohio). I have also, a cousin in Columbus (Ohio) named Grafton DOUTY, a very fine fellow, an active member of the capital city council. He is the oldest son of my father's oldest sister (Cordelia HARN DOUTY). Isabella has a brother residing three miles west of Elkhart in your state. He is named Elisha HARN (Elisha HARN, son of Denton HARN, not to be confused with the other unplaced Elisha HARN in KY also alive then). As to Aunt Harriett Grimes (Harriett HARN GRIMES, sister to Eden H. DAVIS' mother, Hester HARN), I know nothing of her since you saw her the same year, I think, not since. The relations at St. Marys (Ohio), descend from Denton HARN a brother to your mother. William, a son of Denton's, resides at Carlisle, Pa., and Singleton near my mother (near Libertyville MD).



Here the letter (written by George Upton HARN) seems to break off right in the middle of the narrative and the HARN family has lost much reliable information as to its genealogy.

At the time this letter was written, my (Ellen D. HARN's) sister's husband, A.D. Williams, was president of West Virginia College, an institution of learning located at Flemington, Taylor County, W. VA. George Upton Harn II, was a student in the institution. Mr. Davis, probably, obtained his address from the school.

Mr. Harrison

If it please the court, and you say brethren of the Bar -

It seems appropriate when one of our number has been taken from us, who was long with us, and who by the power of his intellect and Kindness of his heart, for many years inspired deeply both our respect and affection, that at least some passing notice should be taken of the sad and instructive event.

Our friend is no longer before human tribunals as an advocate-he is a party now in the world of spirits. As we contemplate this sad event, in this place, the shadows of the past gather over us; the memory of events long gone crowd upon us, and the shades of departed members of this Bar, seem to hover about us, and wait to receive into their midst the spirit of one who was worthy to be a co laborer with them in the profession. Henceforth he must be to us as one of them.

I, do not propose upon this mournful occasion, to indulge in the language of panegyric. My regard for the memory of the dead, and for the obligations of the living, would equally rebuke such a course.

The severity of truth, is at once our proper duty and our best consolation. My knowledge of the early life of Mr. Davis, is very limited, and was derived from himself. The years of his early manhood were passed in obscurity, and devoted to manual labor, sometimes he was employed as a Carpenter, and at other times in farming. I, became acquainted with him when I was a student, in the year 1845. He then resided at Morristown, in the North part of this County, and held the office of Justice of the Peace of Hanover Township, his sun was then near its Zenith.

It is said, there is a Divinity that shapes our ends. Rough hew them as we will, and it may be said that but for the circumstance of the election of Mr. Davis, to this obscure position and his subsequent entry upon the duties thereof. At this period he attended the sessions of our Courts and acquired a limited practice. In the year 1849, He removed with his family to this place, and at once entered upon the practice of his profession. He soon came into active competition with such lawyers as Judge Wm. J. Peaslee, John Rymand, Judge Logan, Thomas A. Hendricks, Martin M. Ray, and other distinguished members of the Bar. With few advantages save those anfered by nature, without the ben-

efits of a liberal or collegiate education, Mr. Davis soon rose to the front venule. He was endowed with a venerable retentive memory, Quick perceptions, and a calm collected self poise, which no excitement could ruffle or disturb. The excellence of his natural faculties was soon displayed. His assiduity, skill, fidelity in professional engagements, and incorruptible integrity secured public confidence.

In the year 1855, Mr. Davis formed a co-partnership with the late lamented Judge Cyrus Wright in the practice of the law, and from that time continuously up to 1872, and until he became afflicted with the lingering disease, which terminated in his death. He had but few equals and no superior as a practitioner at this Bar.

Mr. Davis from the nature of his affliction and disease declined very gradually, and although his death has been expected for many months, the shock it produced, and the tributes of respect to his memory exhibited by his fellow citizens, attest the depth of the public sorrow.

Mr. Davis, was no less remarkable for his social qualities than for the excellence of his legal abilities. To the young members of the Bar, he always extended a word of Kindness and encouragement, and was always affable and courteous to them., when they deserved it, they were sure of receiving from him instruction and expressions of commendation. It was this feature in the character of Mr. Davis, that first attracted my attention and won my esteem for him. Yet he was not a man of negative character by any means. He knew perfectly what was an unworthy act, and had a clear apprehension of who the actor was. He hated oppression in any form, and anything addressed to him in the shape of dictation was offensive to him and was certain of his rebuke.

Self reliant and determined as Mr. Davis was in all his actions, he was, nevertheless anciliating. He did not obstinately adhere to things impracticable. If he could not accomplish the best, he contented himself with the nearest approach to it.

Mr. Davis never occupied official position other than the one alluded to, and that of Notary Public. Although he possessed elements of character which would have enabled him to succeed perhaps in no less degree in politics, than at the Bar. But coming to the Bar late, with a family and limited means, and having already experienced what many other have, that without means there can be but little leisure, and with leisure not much thought. He like a true rotary, devoted his remaining years and energies to the shrine of the profession of his choice, with the results of substantial success.

He was no servile follower for breed. And could not like some be led.

His egotism had sometimes been spoken of during his life, but it was the simplest kind of egotism, if indeed it could be called such, and had for its basis a peculiarity in his practice, which was, that in the course of the most protracted trail, He kept no notes or written memorandum of the testimony, and in his argument to the Court or to the jury, He relied solely upon his memory as to what the evidence had been in the cause, and it is but justice to his memory to say that in this, as a general rule, he was correct.

In Memorium of Eden H. Davis, Deceased continued...

He had no envy in his composition. He never assailed another, or tried to pull him down that he might rise himself. Detraction he was not guilty of. He was ambitious, but his ambitions was to surpass you, not to ruin you. He may have been but too ambitious of success, if so, it is but fair to admit that it a fault of our profession, especially among its leaders. It may be said in this connection that there is more truth than fiction in those profound lines of the poet.

He who ascends the mountain top shall find Its loftiest peeks most wrapt in clouds and snow; He who surpasses or subdues mankind, Must look down on the hate of those below.

The religious character of Mr. Davis, does not afford matter for special remark from me, further than to say that in his belief he was a universalist. He attached less importance than is usually done to religious controversial dogmas and ceremonies, and the lines which divide orthodox churches. He was not a bigot, but in the contrary was tolerant, and could fully appreciate the merits of other denominations. Mr. Davis, was hospitable and sociable in his private relations. He was a kind husband and an indulgent parent. His tastes and habits were pure and simple. He did not gamble or indulge in the use of intoxicating drinks, and even derided the use of tobacco. He was endowed with a nice discriminating taste for order and neatness, and readily detected anything out of place either in his office or at his residence. His dress was neat and plain, deriding all superfluities, and he was particular and neat in his handwriting.

It is the teaching of inspiration that "no man liveth and no man dieth unto himself." Hence there is a lesson taught no less in the death than in the life of every man, eminently so in the case of one who has filled a large space in the thoughts and regard of his fellow men. Particularly instructive at this time in the event which we now deplore, although the circumstances attending his decease were such as are calculated to assuage rather than aggravate the grief which it must necessarily cause.

The three score and ten making the ordinary period of human life had been nearly reached, and full of years and of professional honors, he has gone to his rest. I know not what kind of monument may be erected to perpetuate his memory, but this I may say, that as long as the Records of the Courts of this County are preserved and resist the corroding effects of time, the memory of Eden H. Davis, will not be lost to any who have ever known him.

1st Resolved that we recognize in the death of our worthy brother Eden H. Davis the hand of that providence to whose dispensation we all bow with reverence and humiliation.

2nd Resolved that the deceased was a worthy citizen exemplary husband and father and one of the brightest ornaments of the Bar from the time of his admission in 1846 until 1872 at which time by reason of age, labor and diseased mind and body he was compelled to retire from the Bar to private life since which time his decline mentally and physically has been continuous until his death on the 31st day of May 1878.

3rd Resolved that we will ever cherish the memory of the deceased with greatful rememberance of his many kind deeds, and we hereby tender our heartfelt sympathy to his bereaved family.

4th Resolved that the members of the Shelby County Bar attend the funeral of our now deceased brother in a body and that they cause a copy of these resolutions to be entered of record in the Shelby Circuit Court, and that the secretary of this meeting furnish the family of the deceased a copy thereof.

Ellen Dorcas HARN's Research Notes on the DAVIS Line in KY

Ellen did most of her genealogy research prior to 1895. These notes were written or revised as late as 1906. Ellen died in 1930, age 101.

HESTER HARN DAVIS The date of birth of Hester Harn, daughter of John Harn (I) and Dorcas Davis, is unknown. As given by her son Eden H. Davis, her marriage to his father, John Davis, took place somewhere between 1792 and 1794, in Maryland. She probably is one of the older members of the family, as she married before she left Maryland. With her husband, her husband's father, and her brother **Elijah HARN**, she emigrated to Kentucky in the fall of 1793, and located in or near Flemingburg, Fleming county, of that state. In the year 1828 Mr. Davis and his wife Hester emigrated to Indiana and located at Shelbyville. Hester Harn Davis died October 11, 1831, and **her husband John DAVIS** (of Garrard), August 7, 1837.

In a letter from Mr. Bruce Johnson, dated April 26, 1899, who was brother to the first and second wife of **Eden H. Davis**, **says there were five children born to John and Hester Davis**. Eden H. Davis, a son of John and Hester Davis, in a letter dated March 7, 1879[?] says: "Of my father's family there are still four alive out of tenmyself, two sisters and my only brother." It is presumed that this discrepancy is owing to infantile or early deaths. As Eden H. Davis gives no names, and few dates, concerning his father's family, I make a record of the information obtained from Mr. Bruce Johnson. He says: "They had five children, three girls and two boys."

DORCAS DAVIS (the younger) married a man by the name of **Foxworthy**. They had no heirs. In a letter from Mr. James Foxworthy, a son by the first wife of Dorcas Davis' husband, writes as follows: "Miss Dorcas Davis and my father were married in Fleming county, Kentucky in the fall of 1830, October 23, I think as well as my memory serves me, I being twelve years of age. Miss Davis was my father's second wife. I came to Indiana in the year 1849. I do not know the date of her death. She was the mother of five children: **Anne, Emily, Clarisa, Hiram** and **John**. He was the youngest. All are dead but Emily and Clarisa. They live in Mason county, Kentucky.

EMILY FOXWORTHY was married to **John Higgins** and moved to Missouri, where Mr. Higgins died of small -pox. Mrs. Higgins came back to Kentucky and then was married to Mr. **Reece Davis**, her present husband." In a letter from Mrs. Reece Davis, dated Mt. Carmel, Kentucky, Sept. 7, 1901, she says: "My mother died January 7, 1871, and my father, 1875."She also adds concerning her relatives, Elijah Harn's family: "There were three families of that name living in this county some ten or more years ago. What the relationship was I never knew. The men are all dead and their families scattered."

CLARISA FOXWORTHY married one **Mr. Calvert**, says Mr. James Foxworthy. He is dead. She has one daughter living. Mother and daughter are living in Kentucky.

JAMES FOXWORTHY In a letter dated August 27th., 1906, Knightstown, Ind., says of himself and his ancestors: "I am now past 84 years old, born in the year 1817 in Fleming county, Ky. My father was born in Virginia in the year 1798. He was the son of William Foxworthy. My mother was born in Maryland. Her maiden name is Mary Anne Calvert, a daughter of Anne Wood Calvert. My grandmother Calvert's name was Anne Wood Hemston. My great grandfather, Landon Calvert, was a relative of Lord Baltimore of Maryland. I am the only one of my fathers children living. There were seven of them." Mr. Foxworthy, for a man of his years, indites a most readable letter. There are no signs of declining mental vigor and his firm, steady chirography is in keeping with his clearness of expression. His letter gives evidence of more than ordinary natural abilities.

HARRIETT DAVIS Was a daughter of Hester Harn Davis and her husband John Davis. She was married to **William Meredith.** There were born to them four sons:

DR. JAMES MEREDITH is a dentist and lives at Frankfort, this state (KY).

FLETCHER MEREDITH studied law and was admitted to the bar. He was elected Mayor of the city of Shelbyville, Ind., and after serving a term he emigrated to Hutchinson, Kans., where he is now publishing a newspaper. In politics he is a Republican.

Of the other two sons, **George** and **Albert**, we have failed to procure any information.

JOHN M. DAVIS Son of Hester Harn Davis and John Davis, died in 1894, he and his wife having died with two or three days of each other. They left four sons:

LEWIS DAVIS is a silversmith, **LUCIUS DAVIS**, is a carpenter, both living in Indianapolis.

JULIUS DAVIS, lives in Shelbyville, and works at whatever comes handy.

W. R. DAVIS is a conductor on a passenger train running from Indianapolis to Cincinnati, and resides in Indianapolis.

Names of this family was given without dates of birth, hence the order of their birth is not known.

EDEN H. DAVIS Son of Hester Harn Davis and John Davis, was born in Kentucky, June 19th, 1810. According to Mrs. John A. Young, his youngest daughter of Shelbyville, Ind., living Nov. 1st, 1902, he learned the Cabinet-makers trade at Flemingburg, Ky. He afterwards moved to Maysville, that state, and thence to Morristown, Ind., about the year 1832 or 1833. He married **Ebenilla Johnson**, March 26th, 1835, who died March, 1852. Mr. Davis died May 30th, 1878. To them were born three children:

AZOLINE DAVIS, married a Mr. Smithers. Of the three children born to them, are now living, **Hattie** and **Charles** F., both at Shelbyville.

JOHN DAVIS, son of Eden H. Davis and Azoline Johnson, was killed on a railroad.

HESTER ANNE DAVIS YOUNG is the only surviving child of Eden H. Davis and Ebenilla Johnson (sister of Eden's 1st wife, Azoline Johnson). She married Mr. John A. Young, according to the letterhead of his letter, cashier of the First National Bank, Shelbyville, Ind. Three children were born to Hester Anne Davis and John A. Young, two girls and one boy: Mary Young married a Mr. Tindale. Eden H. D. Young married a Miss Hatch, and Elizabeth Young is still single, living at home.

Aside from the letter of Eden H. Davis to my brother, Thomas Wesley Harn, I am indebted to Mr. Young for the genealogy of this line of the Harn family. He could give me but little direct information, but the clues he gave me whereby results were obtained were most valuable helps. The cordiality and promptness with which he answered all inquiries was most refreshing and pleasing.

MARY DAVIS Daughter of Hester Harn and John Davis, married Mr. Owen Davis. To them was born but one child, a daughter, who married a man by the name of Harper. To Mr. Harper and his wife was born a son, who resides in Shelbyville. By profession he is a school teacher; Quite a bright young man. His parents are both dead.

Mr. Bruce Johnson has this to say of his brother-in-law:

"Now a few words in regard to **Eden H. Davis**. He came here from Kentucky. He taught one or two terms of school, and then for a while followed the cabinet and carpenter trade. He was elected justice of the peace, and while serving as Justice, read law, and by the time his office expired he was able to pass examination, and was admitted to the bar. He was a man of great memory. He soon became the foremost attorney of the bar. He was never known to write down the evidence of a witness, but would repeat it word for word. He was esteemed very highly by the bar. They once presented him with a fine gold head can. In politics he was a Republican and was at one time spoken of as a candidate for Governor of the State. In religion he was a Universalist." When the above letter was written, April 25th., 1899, Mr. Johnson was in his eighty-fifth year and though suffering with rheumatism, indited me a most cordial and prompt answer to my many inquiries.

DEATH OF EDEN H. DAVIS (son of John and Hester HARN DAVIS)

In the death of **Eden H. Davis** the people of the community sustain a great loss and the legal fraternity an eminent counselor. For years he was regarded as an able, careful and safe legal advisor. His varied and extensive knowledge of human nature, his indomitable will and excellent memory rendered him formidable in a legal contest. He was pre-eminently a self-made man, and by his own industry and perseverance attained his high position at the bar.

A few years of his later life were rendered a blank by that dreaded disease of all great brain workers, "softening of the brain." His death occurred May 31, at high meridian. His remains were followed to the tomb on the following Sabbath by a very large concourse of citizens, friends and relatives. The funeral services at the residence were conducted by Rev. B. F. Foster, of Indianapolis, after which the remains were taken in charge by the Masonic fraternity, numbering several hundred, conveyed to the tomb, and buried with their usual form and ceremony.




John M. DAVIS son of John DAVIS and Hester HARN. B. 1817 in KY. D. 1892 in IN.

Benjamin Davis, died 1837 two years before the first daguerreotype.


But what took you that Fall and not the next? Did a comet hanging in the corner of the night sky lift the veil just enough for you to slip through?



Morristown was the third town organized in the county. It was laid off May 3, 1838, by Rezin Davis (of Gerrard) and Samuel Morrison, and has from the start been a place of considerable importance. It was named by Mrs. Nancy (Clary) Davis (wife of Rezin Davis), a noted person among the early settlers, in honor of the Rev. S. Morrison, a wellknown pioneer preacher of this region. A curious old tradition has fastened itself to the hill in the center of Morristown. It is said that a treasure was concealed there ages ago by the aborigines. For many years, even as late as twenty years ago, Indians have been known to come and linger around the spot, encamping for weeks and weeks, and loath to take their departure.

CALEB HARN & HIS BROTHER ELIJAH HARN 1785

According to, Western Maryland Genealogy by Donna Valley RUSSELL (Vol. 2 page 83), Caleb and his brother were jurors in a trial in Frederick Co. in 1785. The book describes the case briefly:

"JACOB, Negro, the property of John Dorsey of John. 27 March 1785 at plantation of Richard Lawrence. Jacob ran away from his master on last Wednesday, a week, and laid out; the weather being very cold, he perished from the cold. Jurors: Abraham Haff, Nicholas Hobbs, Samuel Cook, Joseph Hobbs, Nathan Maynard, John Mackelfish Jr., Lodewick Brickerer, Nathaniel Burkett, Redmond McDonel (X), Benjamin Becraft, Caleb Harn (X), Elijah Harn (X), John Dorsey son of Edward."

Of the 13 jurors, 3 have an "X" after their names, including Caleb and Elijah, indicating they were illiterate. This would contradict the description of Caleb given by Ellen D. HARN. However, there is a small possibility he could read, but not write. To qualify as jurors, they (or their wives) would have needed to own 50 acres of land, or own other property worth at least 50 pounds sterling. There is no record of Caleb or Elijah owning land and the exact juror qualifications are not clear. Caleb & Elijah would have been in their early 20's.

LouAnn HARN CAMERON says:

Recently I visited my daughter in VA. While there I went to the National Archives and read the pension file of Susannah Norman HARN, mother of John D. HARN (Jr.). John D. HARN (Jr.) enlisted in Co 1, 17th Rea't Indiana Volunteers on 29 Sep 1864 (he did fight for the North - maybe he came to Indiana to live with his uncle (sic: first cousin), John M. HARN (son of Lawson and Mary Ann Overly HARN). The soldier was killed in action at Plantersville, Alabama on 1st April 1865." On 14 Aug 1865 Susan (Norman) HARN of Fleming Co., KY, age 63, stated she is the widow of John Harn and the mother of John D. Harn, a private in Co. 1, 17th IN Mounted Infantry who was killed in service at Plantersville, Georgia, on 1 Apr 1865. He died of a wound re-

ceived while carrying the flag of his country and in the line of duty in the service of the United States. John D. HARN, Sr. died 18 Feb 1859. This mother is shown to have been dependent upon the assistance of the soldier ever since. He contributed to her support by purchasing for her all necessities amounting to about \$300 per year. Her property consists of the house she occupies worth \$390, that being what she paid for it in 1860.

Shelly HARN MARTIN says: In some family notes that I received from my uncle before he passed away, he wrote: "John M. HARN was born in Flemingsburg, KY in 1839. John M. married Esther Call in 1866 at Indianpolis, IN. They settled in Clermont, IN (Note from Shelley: Their house in Clermont was the house John M. walked back to after he was released from the rebel prison. It remained in our family until 1988. I visited there many times growing up.) John M. and Esther Call had three children: Jennie Agness Harn, born in Rossville, IL 12/27/1867, died March 1904. Arnold Call Harn (my great-grandfather) (Arnold Call was known as A.C. or Chubby, which he wasn't chubby at all) Arnold Call was born in Clermont, IN 5/15/1869 and died in Peru, IN 4/18/1934. Grace Harn was probably born in Clermont, IN, 1871, lived only 5 years, died of measles 4/1876. In notes my uncle took from his grandmother Harn: "Elijah Harn and Hester Harn Davis were the son and daughter of Caleb Harn (sic). Caleb settled on a farm near Mt. Airy, Maryland sometime in the middle of the 18th century. Elijah & Hester migrated to Kentucky & settled near Flemingsburg."

Notes From The Compiler

And so this project comes to an end... for me at least. You may have noticed that the KY HARNs and DAVISes are not in my direct line. So why did I undertake such a large, painstakingly complex project? In 2011 LouAnn Harn CAMERON and I completed a separate, very large project on the MD HARNs and DAVISes. (Much of that information can be seen at www.harn-ancestry.com). We then agreed to try to find living descendants of Elijah HARN m. Cassandra DAVIS and Hester HARN m. John DAVIS. We knew both couples took their families to KY about 1795 and that Ellen Dorcas HARN began researching them in the late 1800s. So we had a starting point.

Warning: This book is completely opportunistic in the sense that we mostly focused on whoever popped up. Because of that, the results are very uneven and different branches of the family are represented unequally. For example, we have a lot of detail on Rezin DAVIS' family and descendants in IN but nothing on his brother, Gerrard DAVIS Jr.'s family and descendants. The only reason for this is that Rezin's line showed itself to us... while Gerrard's didn't. We didn't purposefully favor any line over any other line. And while many of the living descendants we contacted gave us information about their families going *back* in time several generations, LouAnn and I focused most of our attention on the origins of the DAVIS family in MD and then on sorting out the first 2-3 generations in KY, IN and OH, moving *forward* in time from the point of their migration to KY.

LouAnn and I share a common ancestor, Caleb HEARN of MD, who had many siblings. So why did we focus on the "two-siblings-who-married-two-siblings" and migrated to KY with their families and in-laws? We have always been fascinated by the idea of Hester and Elijah HARN saying goodbye to their parents, siblings and friends, nieces and nephews, leaving the farms of eastern Frederick Co. MD forever, and heading for the unknown wilds of the KY frontier. Did their parents, John and Dorcas DAVIS HEARN, watch their children and grandchildren disappear in a cloud of dust? Did John and Dorcas HARN ever communicate with Elijah and Hester again? Imagine Hester and Elijah and all the DAVISes floating down the Ohio River from Pittsburgh to Maysville in a flatboat ... old-timers, neighbors and toddlers in tow, well-armed no doubt and drifting, literally, toward their new lives in the new "West." These pioneers captured our imaginations. Thus this book.

We hope this effort, regardless of the many errors it surely contains, will become an extension of the remarkable research Ellen Dorcas HARN completed over several decades in the late 1800s and early 1900s. Our goal was to partly to pick up where she left off and improve on her work, if we could, using today's technology, methods and incredible ease of communication and travel.

This book's weakness: It has no database and no index. Its not even paginated. It can't be searched and it is too wordy. There isn't anything to click on. It must be studied and cross-referenced the old fashioned way...with reading glasses, a comfortable chair and a deep reservoir of patient curiosity. This book may be more of a keepsake than a researcher's tool, although it could be useful to a very patient researcher. Another obvious weakness, already mentioned, is that many branches of the family are completely overlooked.

This book's strength: Since it will be placed in several libraries (Frederick, MD, Westminster, MD, Dayton and Cincinnati OH) and historical societies (Frederick MD, and the Kentucky Gateway Museum Center in Maysville, KY, among others) it may last far longer than any website in existence today. Also, we broke some very important ground on the identity of our DAVIS family in MD, especially who the ancestors of Cassandra and John DAVIS were, and by implication, who Dorcas DAVIS (1) and Caleb HEARNs first wife, Sally (Sarah) DAVIS may have been. Dorcas DAVIS (1) is also LouAnn's and my direct ancestor, so the DAVIS breakthrough was big news for us. We had tried for years to identify Dorcas, without success. As it turned out, by researching the KY HARNs, we were able to shine a brighter light on our own Dorcas DAVIS HEARN too.
